# Observations From Alcohol Misconduct Cases

- Majority of alcohol cases involve junior crew members who return from liberty or report for duty intoxicated.
- The sexual assault cases involving alcohol often included senior level mariners who used alcohol to reduce defenses of junior members.
- A small percentage of the cases involved alcohol being smuggled aboard the vessel or misuse of a liquor locker on a vessel engaged on international voyages.
- In many cases, alcohol was detected due to mandatory testing required after a marine casualty.

### **Credentialing Requirements**

- ➤ 46 Code of Federal Regulations (CFR) Part 10 Merchant Mariner Credential (MMC)
- ➤ 46 CFR 10.109(a): Officer endorsements (e.g., master, mate, chief engineer, first-class pilot, purser, etc.)
- ➤ 46 CFR 10.109(b): Rating endorsements (e.g., able seaman, ordinary seaman, qualified member of the engineer department, oiler, fireman, lifeboatmen, etc.)
- ➤ 46 CFR 10.225: Lists requirements for obtaining a MMC
  - 46 CFR 11: Details officer requirements
  - 46 CFR 12: Details rating requirements







#### **Typical MMCs by Vessel Type**

- In general, commercial vessels greater than 100 gross register tons (GRT) required all mariners to have officer or rating MMCs. (e.g., freight ships, tankers, large passenger vessels, seagoing towing vessels, offshore supply vessels, research vessels, etc.)
- Certain commercial vessels less than 100 GRT require only officer MMCs and the junior crewmembers are considered noncredentialed "deckhands".
  - Includes thousands of small passenger and towing vessels.
- Commercial fishing vessels less than 200 GRT do not require any credentialed mariners.
