What is Poverty?



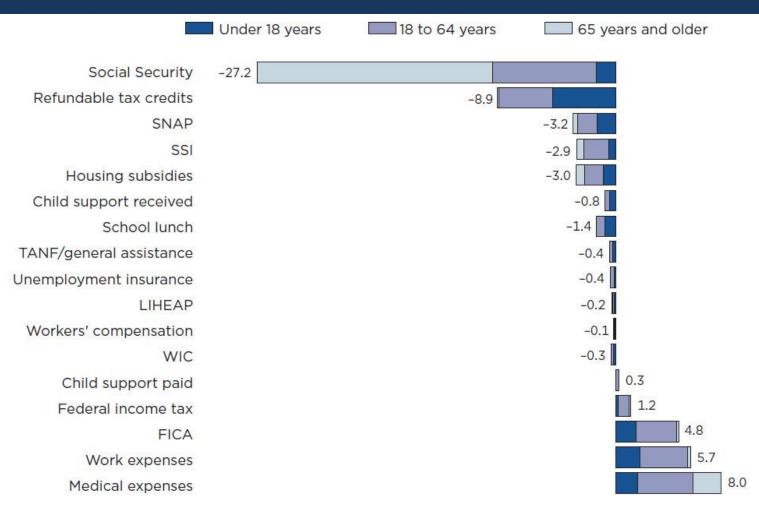
NAS Report: What is Poverty

"We define poverty as economic deprivation. A way of expressing this concept is that it pertains to people's lack of economic resources (e.g., money or near money income) for consumption of economic goods and services (e.g., food, housing, clothing, transportation). Thus, a poverty standard is based on a level of family resources (or, alternatively, of families' actual consumption) deemed necessary to obtain a minimally adequate standard of living, defined appropriately for the United States today."

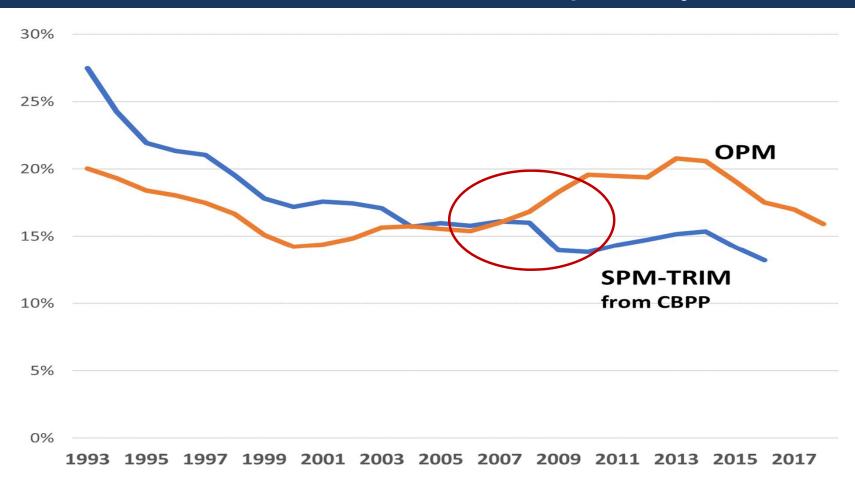
Advantages of SPM

- Resources and Thresholds are consistent
- More realistic "family," and includes foster children
- Thresholds annually updated by changing standard of living
- Resources include all government transfers (net of taxes), and can demonstrate impact of transfers on poverty
- Allows for geographic differences in housing costs
- Attempts to deal with differences in health care and differences between owners and renters
- Better captures who is poor
 - Homeowners, workers, with health insurance, married couples, elderly and inside MSAs

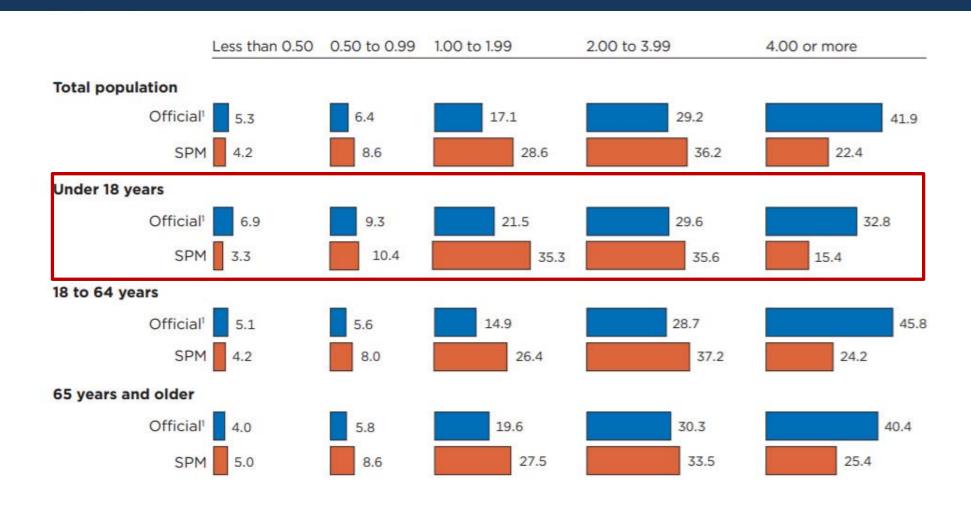
Change in Number of People in Poverty After Including Each Element: 2018



The SPM demonstrates the impact of the safety net over the recession for child poverty



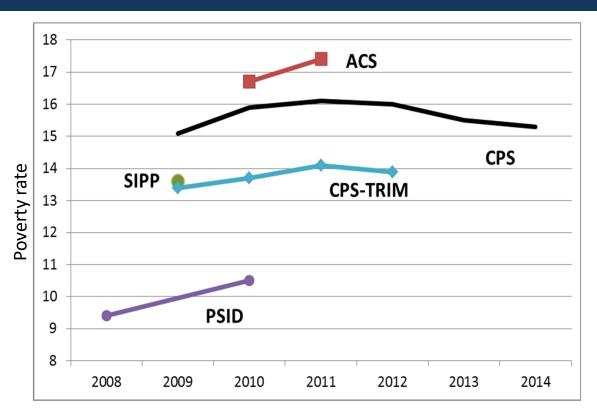
Need to consider the entire distribution



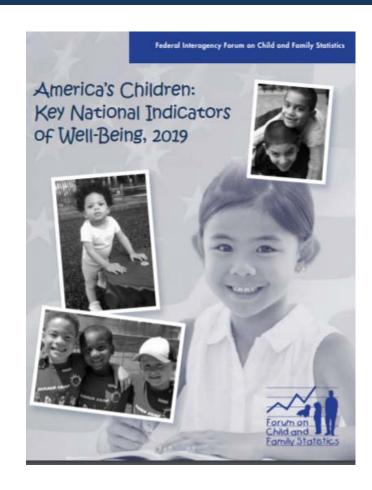
More Research is Needed

Portability across surveys and indicators is important



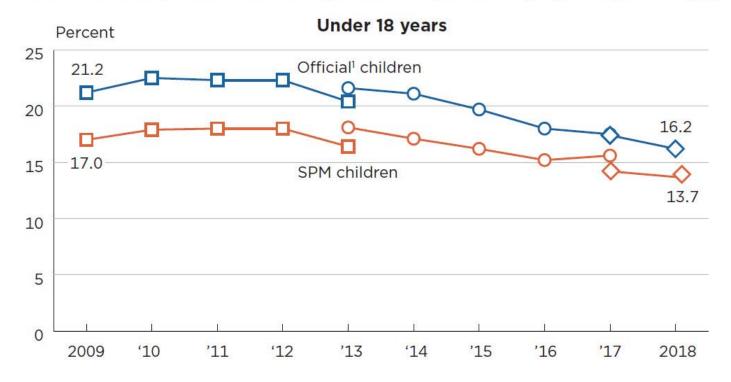

NAS Report on Consumption

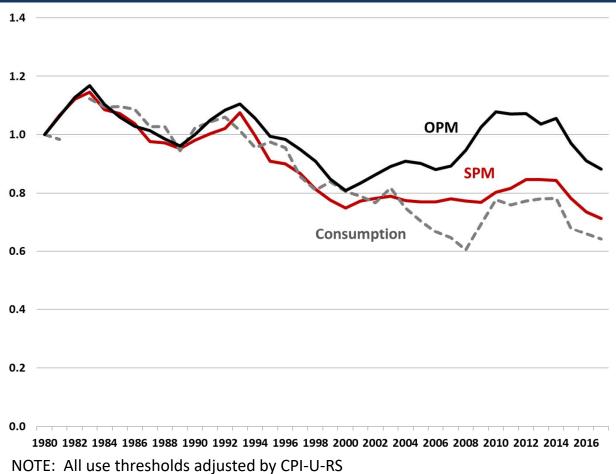
One view is that the poverty measure should reflect the actual level of material well-being or consumption in the society (in terms of the number of people above the threshold), regardless of how that well-being is attained. Another view is that the poverty measure should reflect people's ability to obtain a level of material well-being above the threshold through the use of their own income and related resources.

On balance, many members of the panel find more compelling the arguments in favor of a consumption definition that attempts to assess actual levels of material well-being.

However, in the United States today, adequate data with which to implement a consumption-based resource definition for use in the official poverty measure are not available.

Does it Matter: Trends in SPM and Consumption Poverty (Meyer/Sullivan) are similar

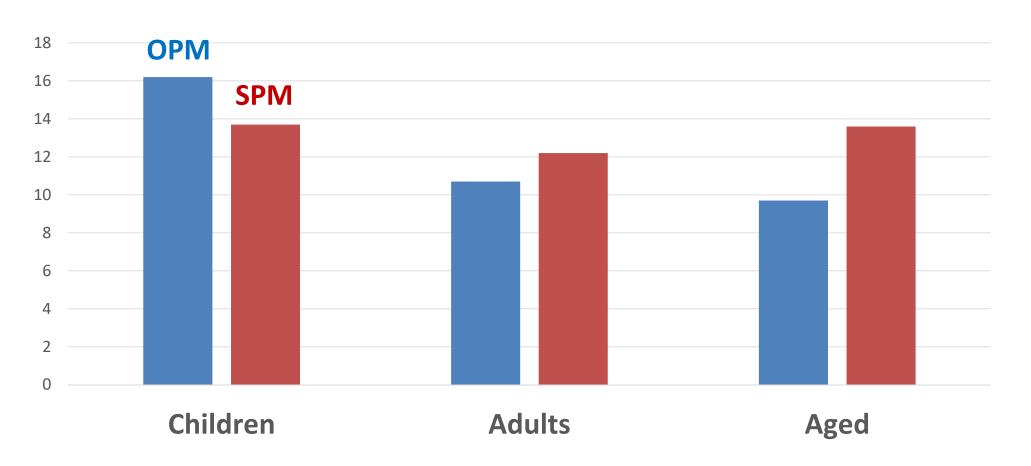
Measurement Issues for Consumption/Expenditures

- Quality of CE data
- Sample size in CE support state-level estimates (currently MSA level)
- How to obtain annual consumption from quarterly CE spending data
- What do we include in consumption
 - Housing, Health, Education
 - Measuring service flows for housing and durables
- What about under-reporting of spending (e.g., alcohol, clothing)
- What do we do about elderly
- How can we examine the impacts of government programs
- How do we determine a consistent thresholds

The Politics of the SPM

- Conservatives Feel left out of decisions in SPM
- The issue with Relative Poverty (Thresholds)
- Need to measure impact of Medicaid and Medicare
- Are Children really better off than Aged

Child Poverty under SPM is Lower than OPM Poverty for Aged is Higher



Can we change the official poverty measure? OMB Statistical Policy Directive 14

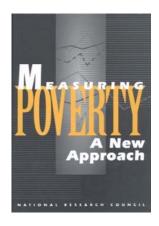
For the years 1959-1968 the statistics on poverty contained in the Census Bureau's Current Population Reports, Series P-60, No. 68, shall be used....

For the years 1969 and thereafter, the statistics contained in subsequent applicable reports in this series shall be used...The Bureau of the Census series continues the Social Security Administration definition for the base year, 1963...

...Annual adjustments in Census series are based on changes in the average annual total Consumer Price Index (CPI) instead of changes in the cost of the U.S. Department of Agriculture's Economy Food Plan...

...Other measures of poverty may be developed for particular research purposes, and published, so long as they are clearly distinguished from the standard data series....

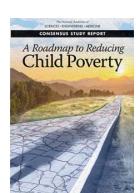
How can we change the official poverty measure? Origin and Critical moments

Thoughts on the Future

- Never use OPM
- Census create an historical measure ala Columbia measure and fix break in series
- Move forward on other data sets (ACS, CE, PSID)
- Keep collaborating, and use funding to conduct and support research at poverty centers
- Produce both anchored and quasi-relative measure and periodically update threshold level
- Produce a pure relative measure
- Have a new CNSTAT Panel on Poverty

Need a New CNSTAT Panel on Measuring Poverty

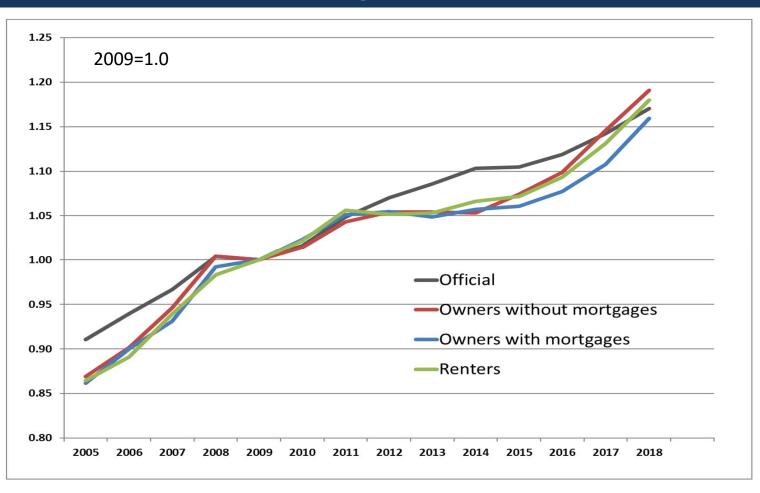
- The FY2020 budget request includes the following program changes: Supplemental Poverty Measure (+\$2,000,000)
- The Census Bureau will fund a research study by the National Academies of Sciences, Engineering, and Medicine to evaluate and improve the supplemental poverty measure.

ITWG Guidance

- According to the ITWG recommendations, SPM should be seen as a research measure, improving due to changes in data, methodology or research
- Priority should be placed on "consistency between threshold and resource definitions, data availability, simplicity in estimation, stability of the measure over time, and ease in explaining methodology (ITWG, 2010)"

The quasi-relative updating method creates differences than using the CPI-U



Consumption and Expenditure distributions differ mainly because of treatment of housing
