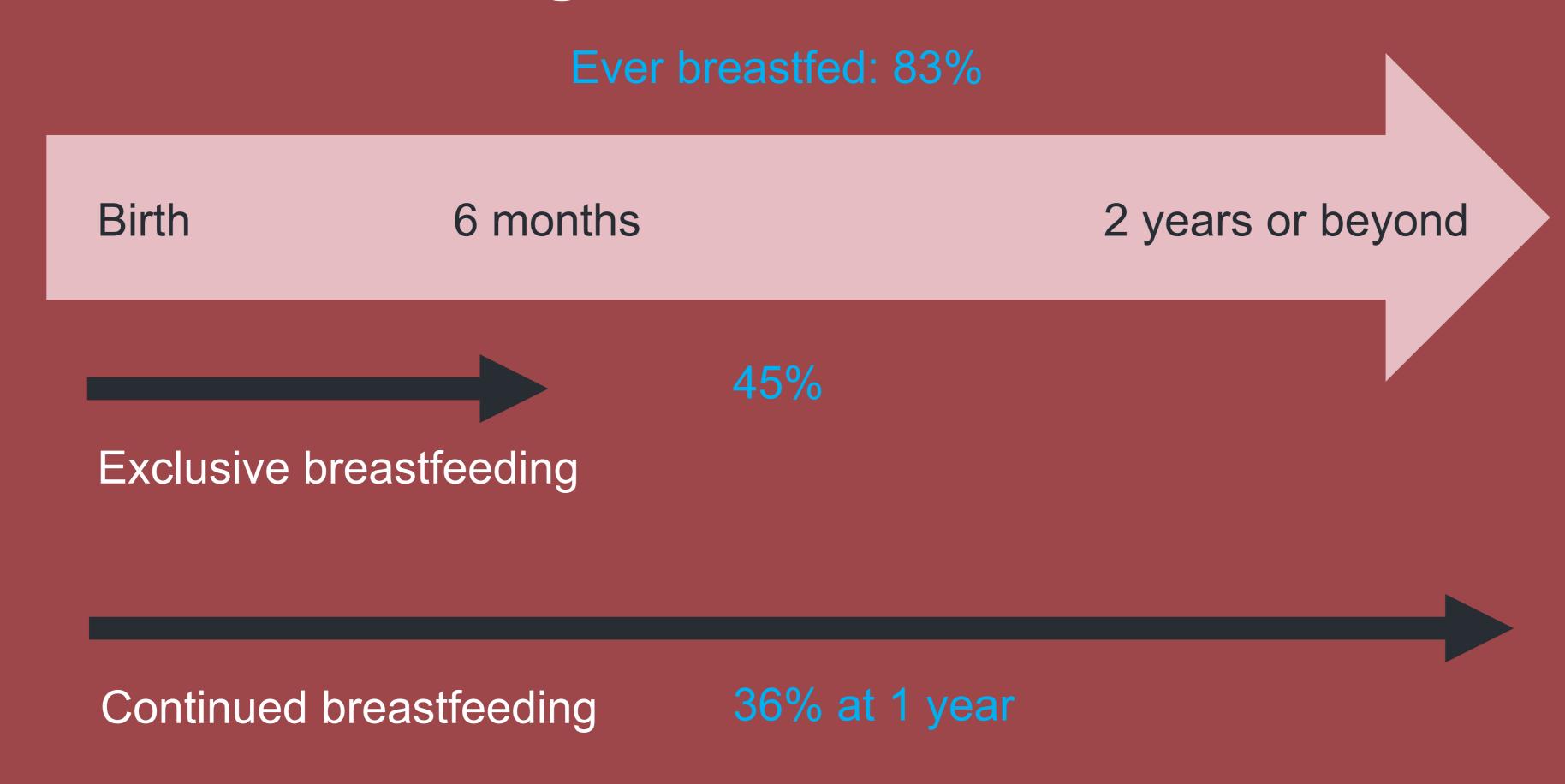

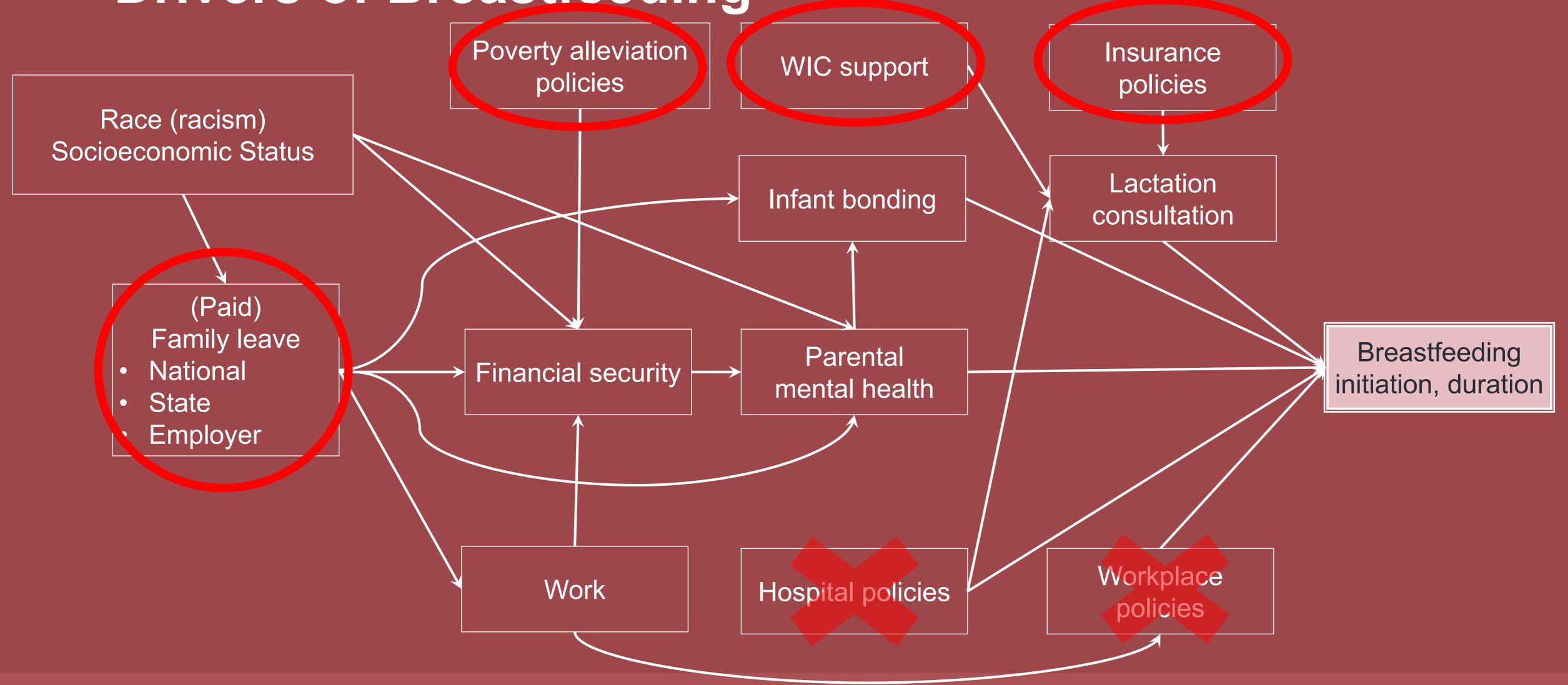

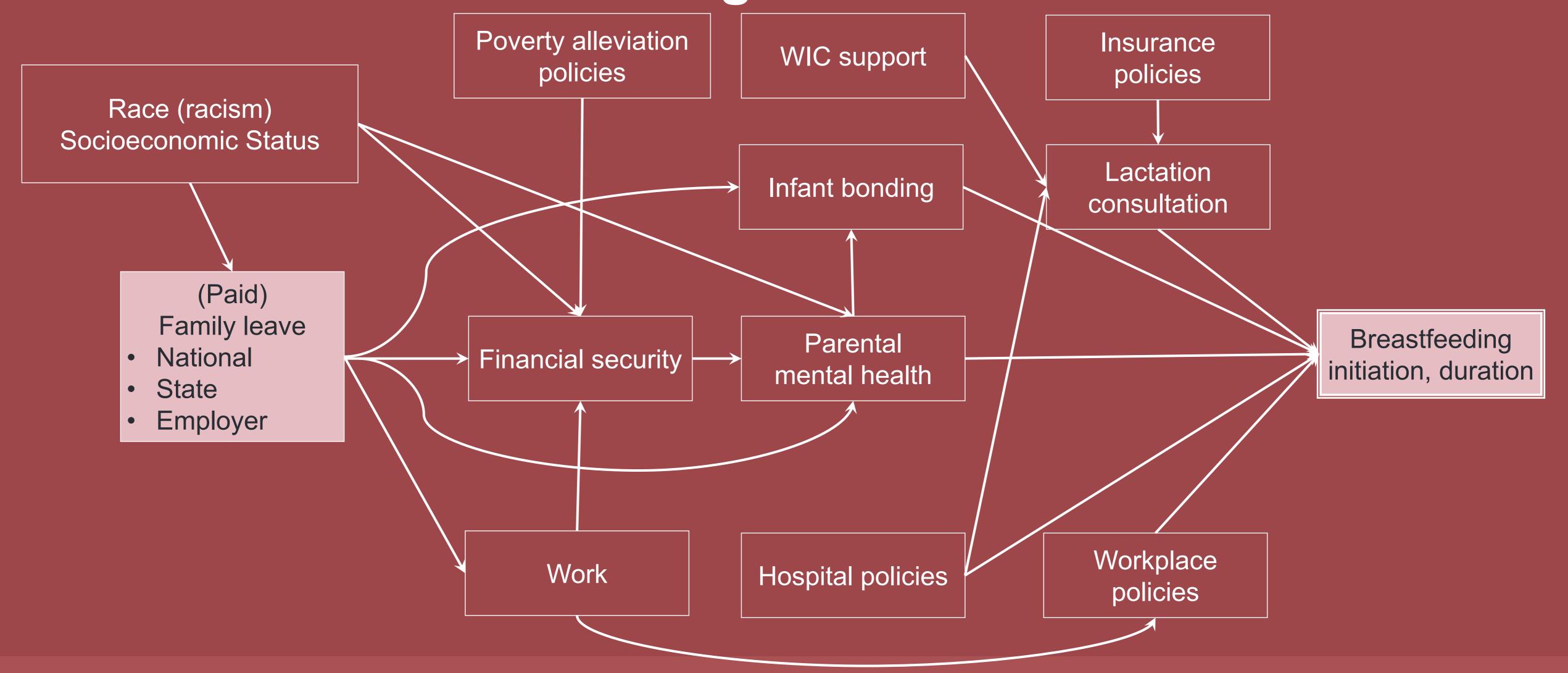


U.S. Breastfeeding Guidelines









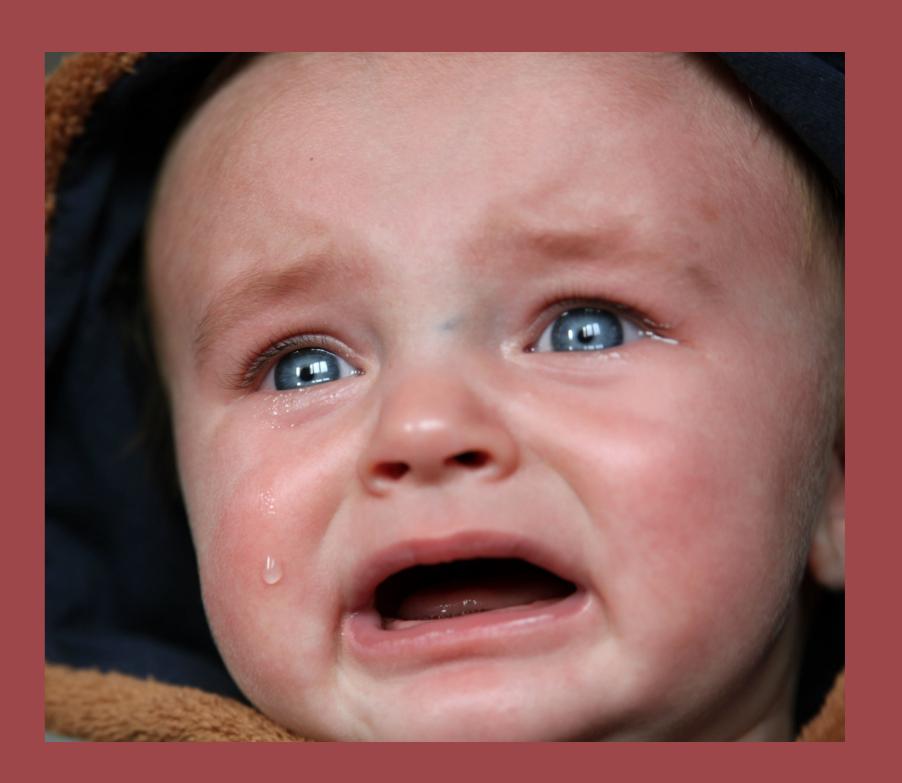


U.S. Family and Medical Leave Act (1993)

Provides unpaid job-protected leave for qualifying workers

More than 40% of employees don't qualify

Low-education workers less likely to take leave





Paid Family Leave (PFL)

Key elements:

Wage replacement

Guaranteed job protection

Intended impacts:

Financial security

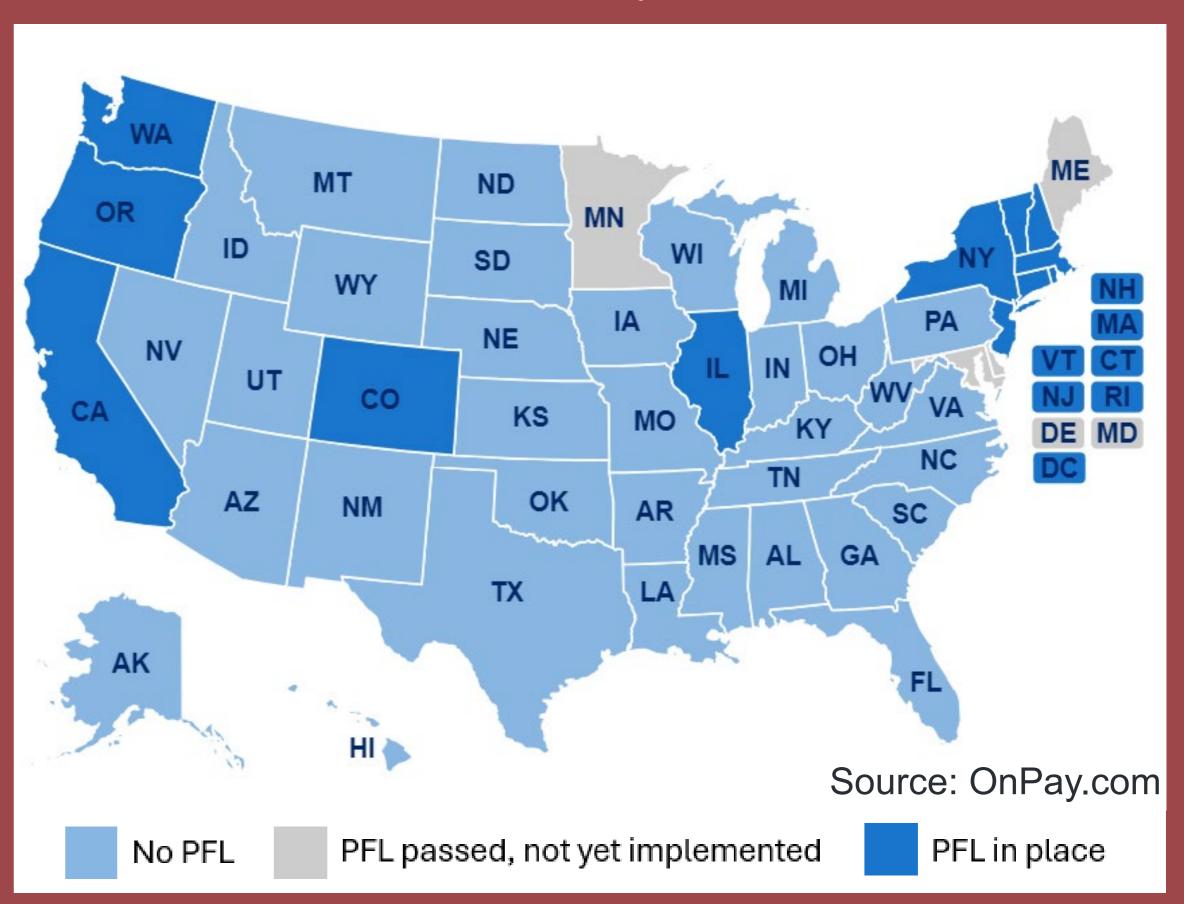
Time for infant-parent bonding

Disparities in PFL access:

27% of private sector workers

Only 5% of low-wage workers

U.S. State Paid Family Leave Policies





Evidence: Association of PFL Policies with Breastfeeding and Mental Health

Improvements in breastfeeding duration (+5 percentage points at 6 months)

Weaker effects on breastfeeding initiation

Consistent effects on parental mental health

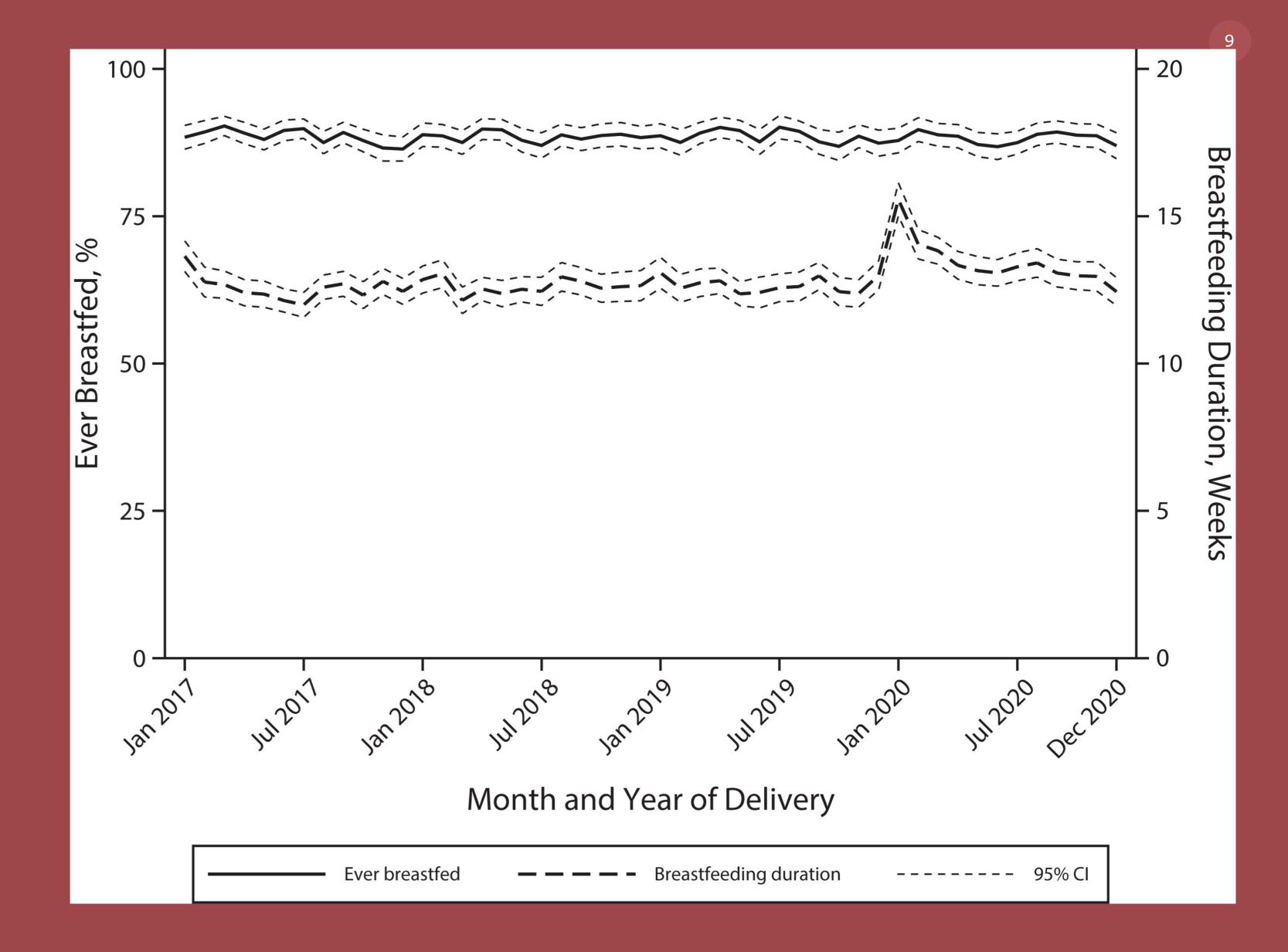
Most studies examine California (2004) and New Jersey (2009) policies

Conflicting evidence on subgroup effects

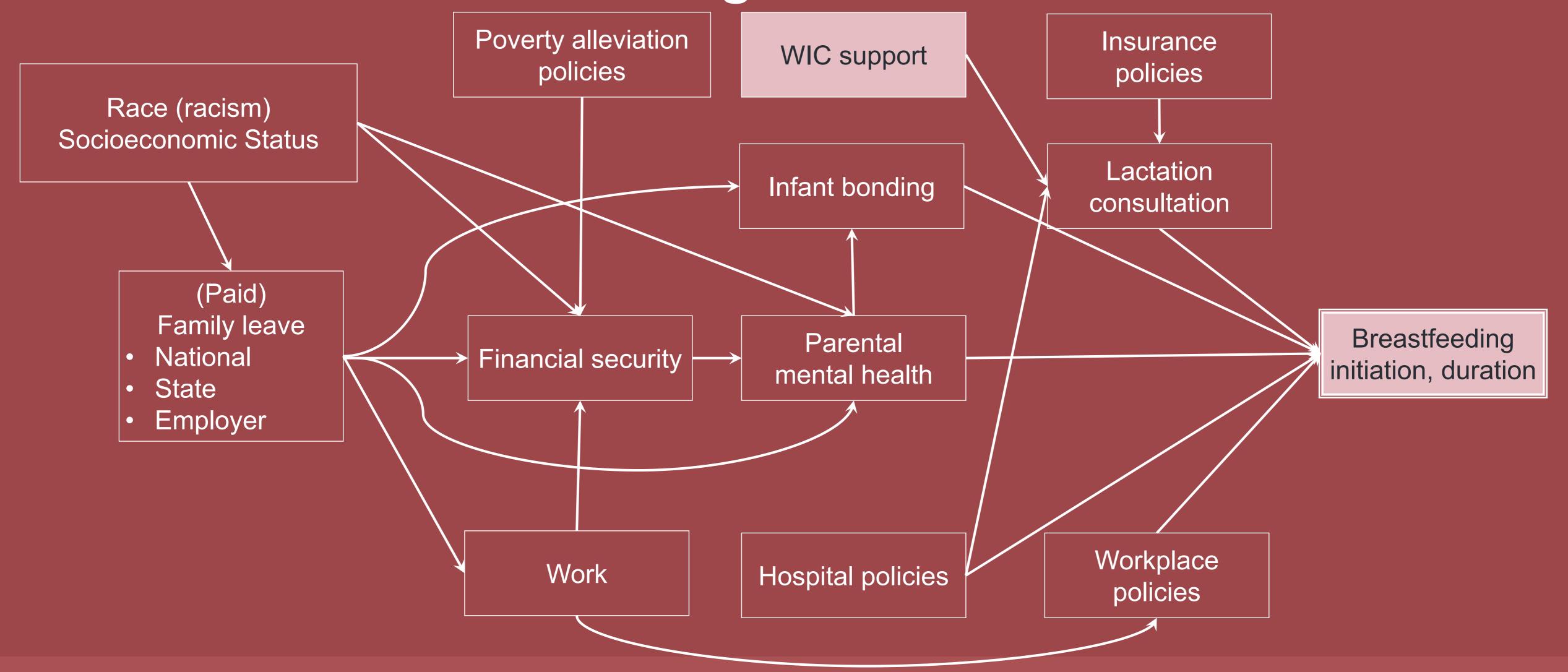
Conflicting evidence on return to work



Pent-up Demand for Paid Family Leave: Breastfeeding During COVID-19 Shelter-in-Place









Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)

Serves >25% of pregnant women, >50% of infants

Provides electronic benefit transfer (EBT) card to be redeemed on specific foods

Provides breastfeeding support and/or formula

Criticism that formula discourages breastfeeding

→ 2009 WIC revision ↑ food to breastfeeding women, breastfed infants; ↓ formula





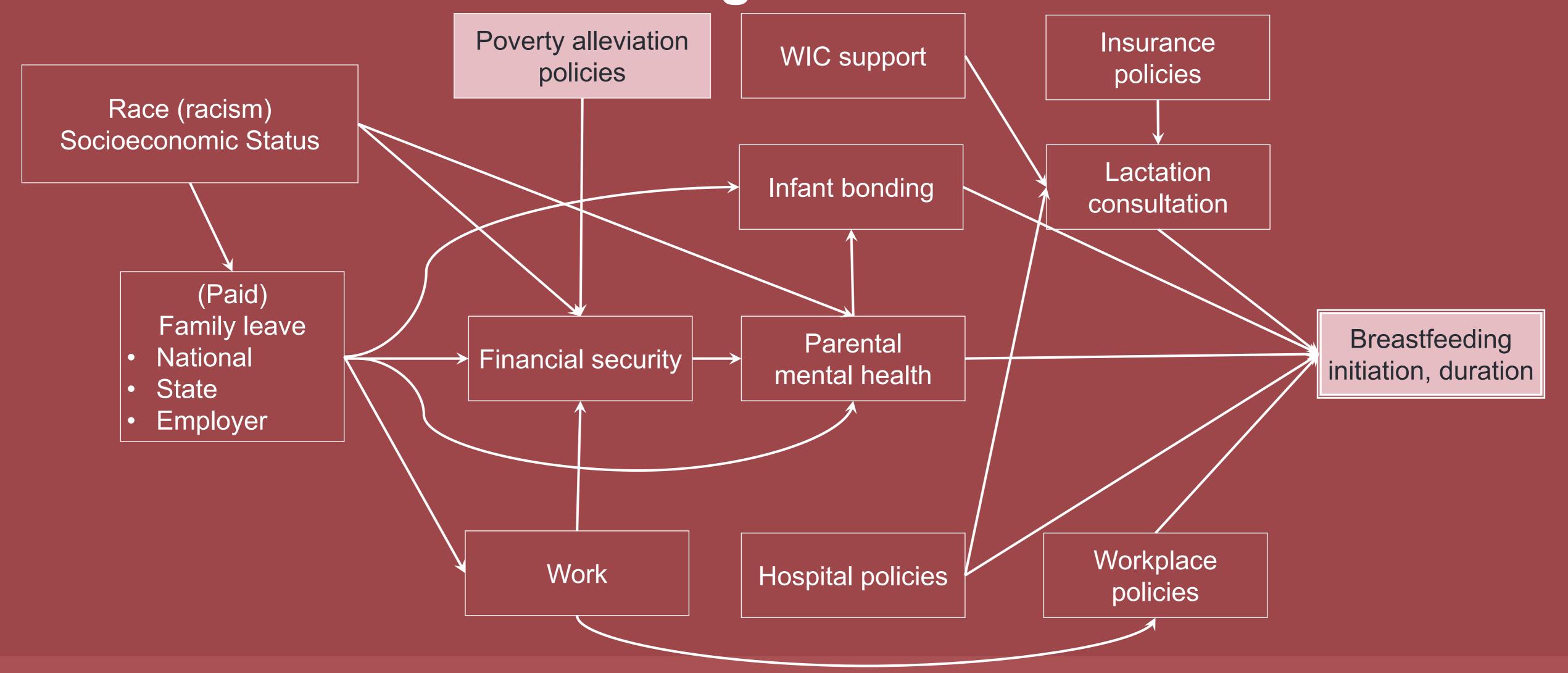
Evidence: Association of WIC Participation with Breastfeeding

Less breastfeeding among WIC participants: free formula vs selection bias?

WIC changes in 2009 contributed to increased breastfeeding

Small studies suggest 2022 infant formula crisis increased breastfeeding







Evidence: Association of Poverty Alleviation Policies with Mental Health and Breastfeeding

Earned Income Tax Credit (EITC): largest poverty alleviation program, ~\$2,500 annually

Numerous studies showing improved mental health

One study found increase in breastfeeding initiation

Temporary Assistance for Needy Families (TANF): short-term for pregnant women or people with children

Adding work requirements (relative to AFDC) worsened mental health, decreased breastfeeding

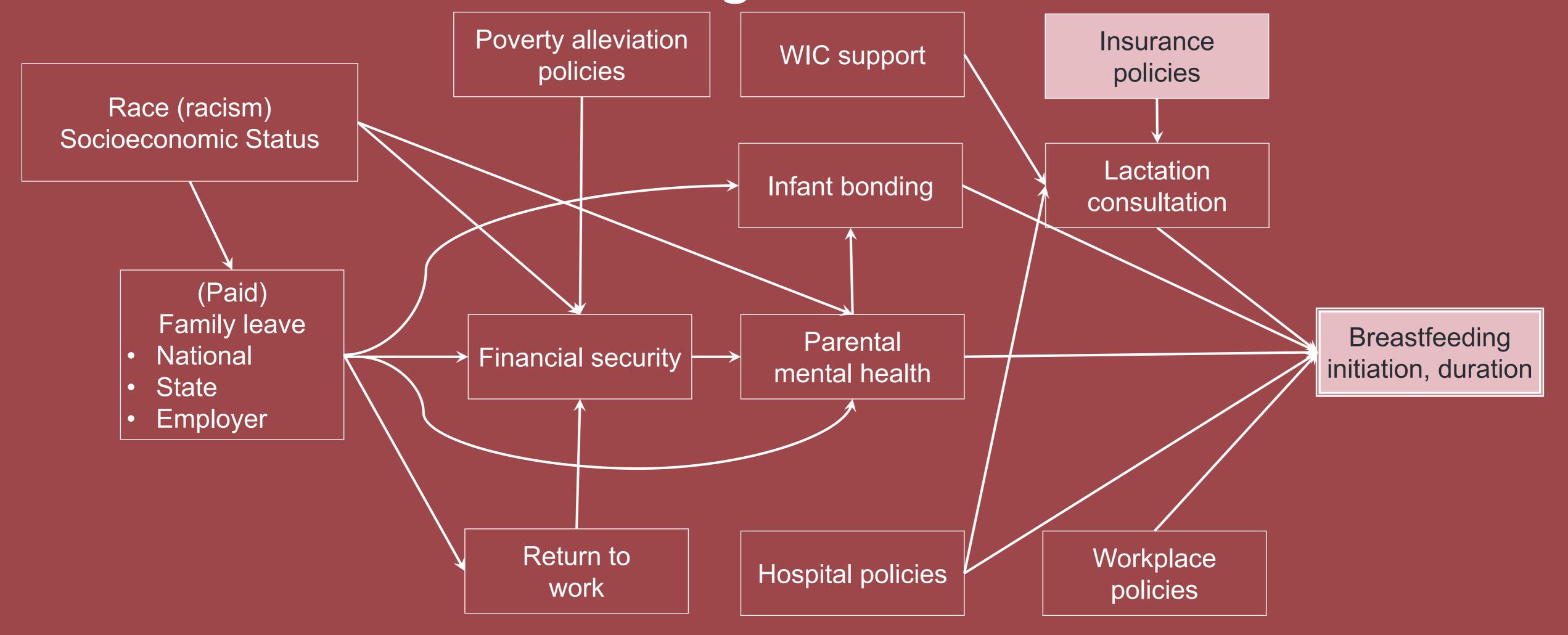
More supportive TANF policies during COVID-19 improved mental health

2021 Expansion of Child Tax Credit (CTC): \$2,000 → \$3,600; middle-income → even zero-income families

Several studies showing improvements in mental health among lowest-income parents

No studies specifically on breastfeeding







Affordable Care Act Coverage

Required private insurers to provide coverage for lactation support and breast pumps (2012)

Required Medicaid expansion states and Marketplace insurers to provide these benefits (2014)

Expanded coverage

Increased claims for breast pumps

Increased breastfeeding initiation and duration

Reduced risk and greater treatment of postpartum depression





Conclusions

Numerous state and federal policies are consistently associated with breastfeeding and mental health

* especially paid family leave

More research needed on state policies
