


Sites implemented many jail population reduction measures through the SJC, going further at the onset of the pandemic.

Many sites significantly reduced their jail populations prior to COVID-19, and reductions were even more dramatic following the pandemic.

Percent Change in ADP From Baseline, Before and After COVID-19, By SJC Site




■ Pre-COVID Change in ADP from Baseline (Baseline to February 2020)

Note: Clark and Charleston did not report January 2021 data.




Outcomes for People of Color have improved, but disparities persist, especially for bookings.



Racial and ethnic disparities persisted or worsened in many sites between February and October, especially for Black People.
