Real-Time 2020 Administrative Record Census Simulation

- Purpose: To show how population statistics compare between an administrative record census and traditional data collection
- Simulation was conducted in the same time frame to determine the length of time needed to execute an administrative records census





2020 Census Program for Evaluations and Experiments (CPEX)

Extending the Census Environment to the Mailing Materials

- Purpose: To increase self-response by tapping into the unique environment surrounding the decennial census through the materials used to contact households and request self-enumeration
- ➤ Treatments: Mail materials that incorporated messaging from the 2020 Census communications campaign, "I Count" stickers provided in the initial mailing, and every door mailing on Census Day to promote the 2020 Census





2020 Census Program for Evaluations and Experiments (CPEX)

Optimization of Self-Response in the 2020 Census

- Purpose: To understand the impact of the mailing strategy and overall influence of the Internet response option
- > Treatments: 2010 Census mail strategy with no mention of the internet response option, the 2020 Census mail strategy with no mention of the Internet response option, switch in Internet First and Internet Choice strategies, and no mail materials provided

2020 Census Program for Evaluations and Experiments (CPEX)

Impacts of the pandemic on the 2020 Census Mail **Experiments**

- Four panels did not receive the experimental mailing materials for mailings 4 and 5; these were replaced with production materials
- Non-responding CPEX housing units received up to two additional, non-experimental mailings that were not in the original mailing strategy
- > The Every Door Direct Mail panel second design was intentionally withheld from the mailings since the images of people responding in public places were deemed inappropriate at a time when the CDC was urging people to stay home
- > The "I COUNT" stickers were designed to be worn or displayed by respondents but changes in public activities within same timeframe of receipt neutralized the intended purpose of the sticker

2020 Census Program for Evaluations and Experiments (CPEX)

- CPEX research projects were generated starting with a call for proposals in 2017
- ➤ The Decennial Research Objectives and Methods (DROM) Working Group reviewed proposals and provided recommendations to form a cohesive research and evaluation program
- ➤ Initial scope of the 2020 CPEX was approved by the 2020 Census Executive Steering Committee in May 2018
- After initial scope was approved, as systems and operations finalized their plans, studies have been added and removed
