Why women's movements matter

- One of most important predictors of policy change
- Develop new awareness of problems
- Influence public opinion
- Challenge conventional understandings of issues.
- Carry out advocacy and influence political institutions
- Help bring about legislative and constitutional reforms
- Influence international, norms, treaties and agencies

Women's Political Representation

- Three times more women in parliament today than in 1995 (IPU)
- One fifth of African parliaments have female speakers of the house (IPU)
- One fifth of ministers are women (World Bank)

Where women's movements have had the <u>least</u> impact



- Changing customary practices, e.g., inheritance rights, polygamy, child marriage
- Ending harmful traditional practices, e.g., female genital mutilation
- Reforming family law
- Implementing legal reform

Conundrum for activists: Autocratic instrumentalization of women's rights

"Museveni intended to offer women an opportunity to get into political structures, and it [his policy] was supposed to motivate them and bring them on board so that their views could be heard, that they would be able to influence the governance agenda.

As I talk now, the affirmative action, as you know, it is a double-edged sword. It can be used by those in power . . . to sustain them in power."
