The National Academies of Sciences, Engineering, and Medicine (NASEM) ad hoc topical committee is addressing specific issues related to nuclear terrorism threats. In this information gathering meeting, the panel discussions on response and recovery will focus on topics from the statement of task on the adequacy of strategies to respond to nuclear terrorism, and identify technical, policy, and resource gaps. Topics include

- identifying national and international nuclear risks, and critical emerging threats
- responding to nuclear terrorism incidents to attribute their origin and help manage their consequences
- budgets likely to be required to implement effectively such strategies

Panelists will include first responders on 9/11 in New York City and the Pentagon, the Center for Disease Control, Department of Homeland Security, and the Federal Emergency Management Agency.
