- Head of Contracting Activity (HCA) authority comes from the Senior Procurement Executive
- Authority levels: >\$50M OAM, \$25-50M HCA, <\$25M Sites

EM Contracting History

- Initially, Management & Operating (M&O) contracts
 - Unique relationship between the Government and contractor
 - General work scope
 - Cost type contract
 - Fee paid either on a fixed fee schedule or incentive basis or both
- Moved toward cost type contracts
 - More cleanup accomplished for the same amount of money
 - More specific work scope
 - Cost type contract
 - Performance based and award fees
- End State Contracting
 - More efficient use of resources completion mentality
 - "Chunking of work"
 - More fee for greater risk

Principles of End State Contracting

- Indefinite Delivery, Indefinite Quantity (IDIQ) contracts task orders
- Initial Period of Performance up to 10 years minimum guarantee
- Contract can be ended after task orders end no terminations
- Very specific work scope potentially allows for firm fixed price
- Proposal preparation and evaluation
 - Key personnel factor
 - Past performance
 - Cost
- Benefits of End State Contracting
 - Quicker evaluations of proposals
 - Less risk of protest loss
 - Frees up contractor key personnel
 - Less proposal cost to industry
 - Extended ordering period of five years
 - Up to 15% fee
- Not all contracts are end state



Small Business Involvement

- Direct contracts to small businesses
 - Use of the SBA socio-economic programs
 - Contracts to Indian country
- Sub-contracting
 - Mandated goals in our large contracts
 - Hold contractors accountable for performance
 - Meaningful work
- Mentor-Protégé program
 - SBA program, but DOE has it's own program
 - RFPs require two agreements
 - Focus on various socio-economic categories
 - Mentors provide technical assistance, business development, planning, strategy, and guidance
- Supply Chain Management Center
 - 60% with small business
 - Self-identify as a potential supplier
 - Partner with prime contractors
 - Metrics contribute toward category management achievement
