Background

- In a public session during the August 2024 telecon, CESAS met with NASA ESD officials and the midterm assessment co-chairs. Our goal was to:
 - Ensure proper understanding of the Midterm
 - Provide member comments as feedback on the report
- Our goals for *this* meeting include:
 - Ensure proper CESAS understanding of sponsor responses
 - Provide member comments as feedback to the sponsors
 - Facilitate open community discussion of both report and responses
 - Help structure the process to motivate discussion and guide resulting actions
- Our ultimate goal is to identify CESAS actions (over the next year+), arising from the Midterm, that best support the community and sponsors

Conclusion

- It is good to see the level of alignment between the Midterm report and sponsor responses. That suggests we're ready to identify next steps.
- CESAS could focus on any of the topic areas, or on any of the underlying 8 topics – priority topics are suggested
- Areas/topics could be pursued through any of the mechanisms available to CESAS, based on sponsor guidance
 - Dedicated projects*, including sponsored reports or workshops (to be negotiated through NASEM)
 - CESAS Meeting Discussions
 - “Ongoing Topics”, designated as important for regular discussion in CESAS meetings
 - “Ad Hoc Topics”, identified on a meeting-by-meeting basis

*Upon agency request and with the approval of the National Academies, CESAS can write short reports related to the implementation of the most recent Earth science decadal survey (see: <https://tinyurl.com/2xhoktj7>). The committee can also assist in the formation of ad hoc committees that would organize approved studies, workshops, or “meetings of experts.”

CESAS General Comments on Next Steps

- For in-depth guidance on any topic, we should consider our breadth and balance of member expertise and augment as needed
- CESAS could benefit from briefings on specific topics (e.g., budget development) as needed to support priority areas
- Meetings and telecons could be structured better – we welcome sponsor suggestions
