- d. Did you trust the organizations that were providing the public health advisories? Why or why not?

Q2. Let's discuss the response as the situation unfolded. What sources of information did you rely on to understand how the release of JP-5 would affect you, your family, and your pets?

- f. Are there any gaps in information that persist?

 - c. What health care needs and questions persist among the Red Hill Patients?
