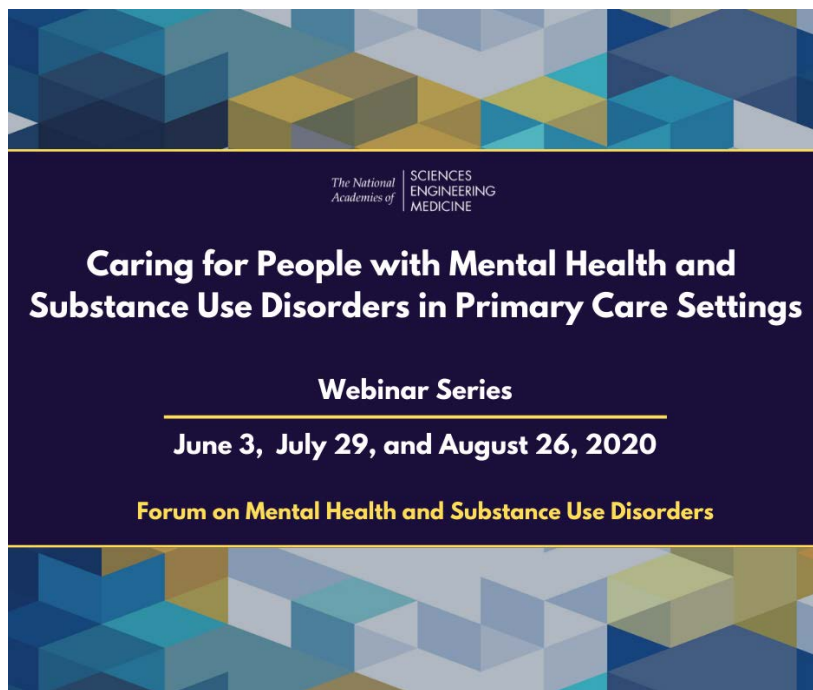


Caring for People with Mental Health and Substance Use Disorders in Primary Care Settings: Webinar Series
