#### People with disabilities are more likely to experience

- Fair to poor health
- Poor oral health
- Depression/Anxiety
- Risky health behaviors (less likely to engage in physical activity, more likely to smoke)
- Chronic health conditions
- Premature mortality

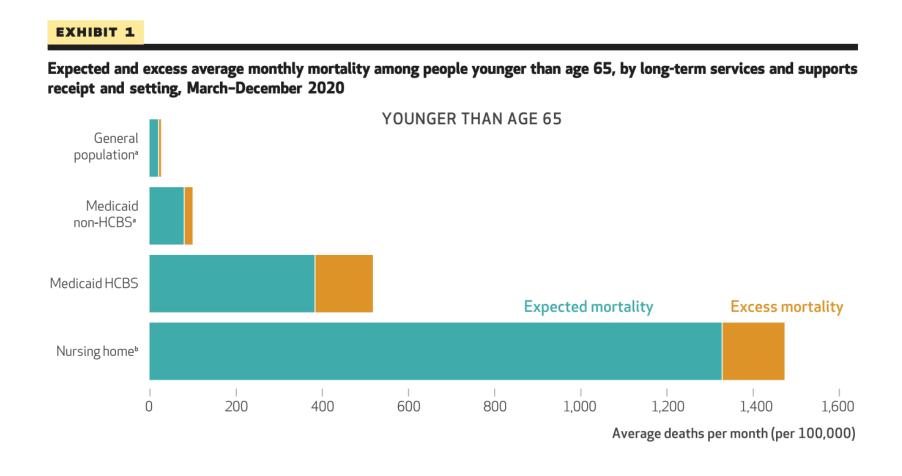
## Health Disparity Indicators: Self-Reported Health & Intersectionality

Among disabled people, self-reported health status varies by race, ethnicity, sexual orientation, and gender identity.

- LGBTQI+ people with disabilities are more likely to report poor physical and mental health.
- Disabled members of minoritized racial and ethnic groups also consistently report poorer health; this is true of people with IDD as well as mobility limitations.

#### Health Disparity Indicators: COVID-19 Excess Mortality

Between March and December 2020, the excess mortality of Medicaid HCBS recipients under the age of 65 was **26.6 times** that of the general population.

#### **Health Disparity Indicators: Severe Maternal Morbidity**

After adjusting for relevant covariates, women with intellectual and developmental disabilities (IDD) have a 75% higher risk for severe maternal morbidity and an 186% higher risk for maternal mortality than peers without IDD.

 Deaf and/or hard of hearing (DHH) women have a 54% higher risk for severe maternal morbidity.

TABLE 2 - Distinctions Between Health Equity and Related Terms



Several terms that relate to health equity are sometimes used inappropriately or interchangeably.

The following definitions help clarify distinctions between them<sup>4</sup>:

Health disparities Differences in health and well-being outcomes without an identified cause among groups of people.

Health care disparities

Differences in quality of health care received that are not due to access-related factors or clinical needs, preferences, or appropriateness of intervention.

Health inequalities

Differences in health status, or in the distribution of health determinants among different population groups (eg, differences in mobility between older and younger populations, or in mortality rates between people from different social classes).

Health inequities

Differences in health and well-being outcomes that are avoidable, unfair, and unjust. Health inequities are affected by social, economic, and environmental conditions.

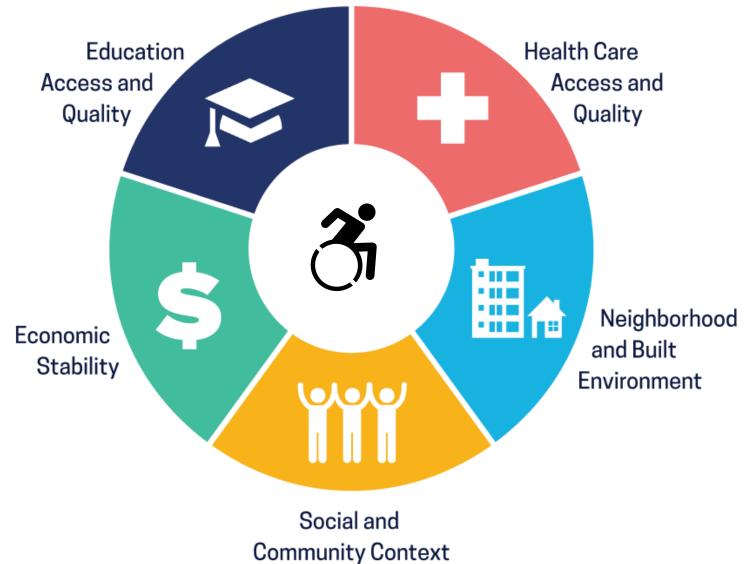

Social Determinants of Health & Disability

#### **Social Determinants of Health**

- Refers to the conditions in which people are born, grow, live, work, and age, as well as the wider set of forces and systems shaping the conditions of daily life.
- These social determinants include factors such as socioeconomic status, education, neighborhood and physical environment, employment, social support networks, access to healthcare, and access to resources such as food and transportation.

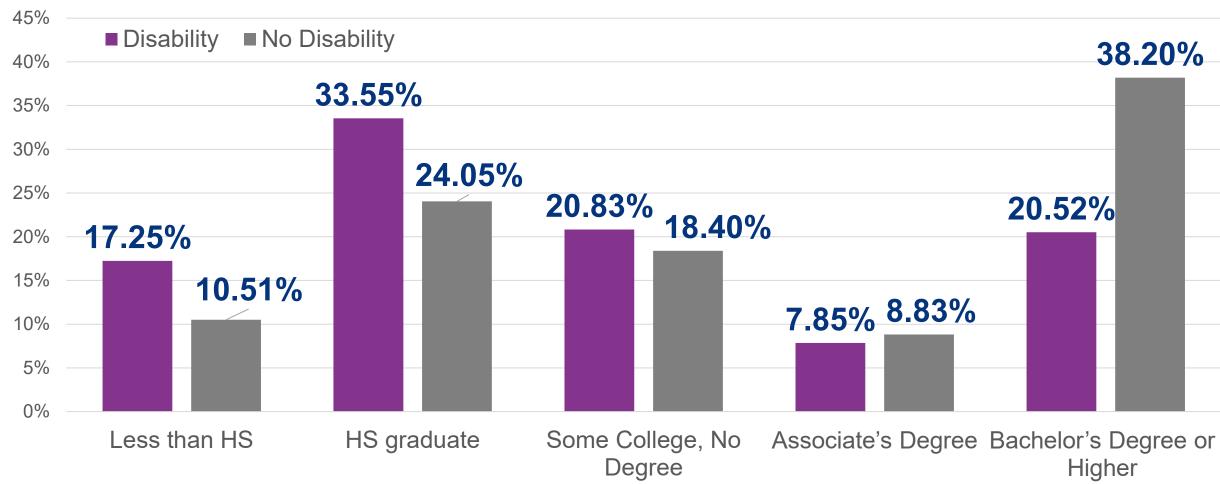

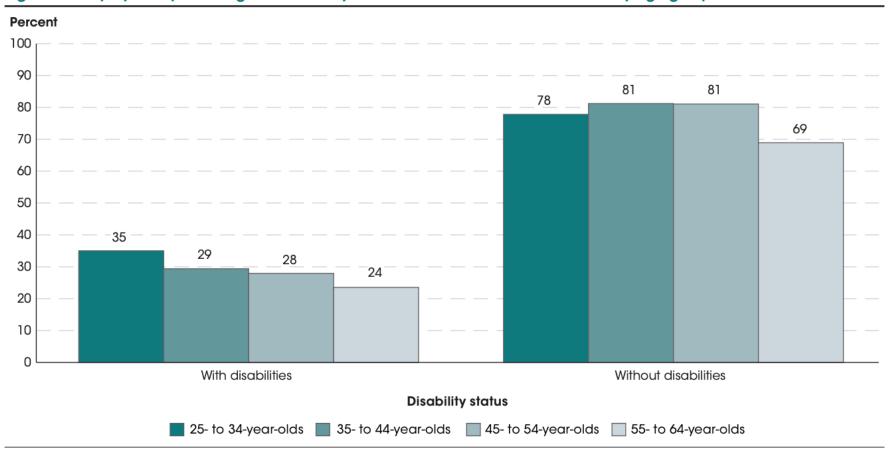

Figure 4. Employment percentage of 25- to 64-year-olds with and without disabilities, by age group: 2015

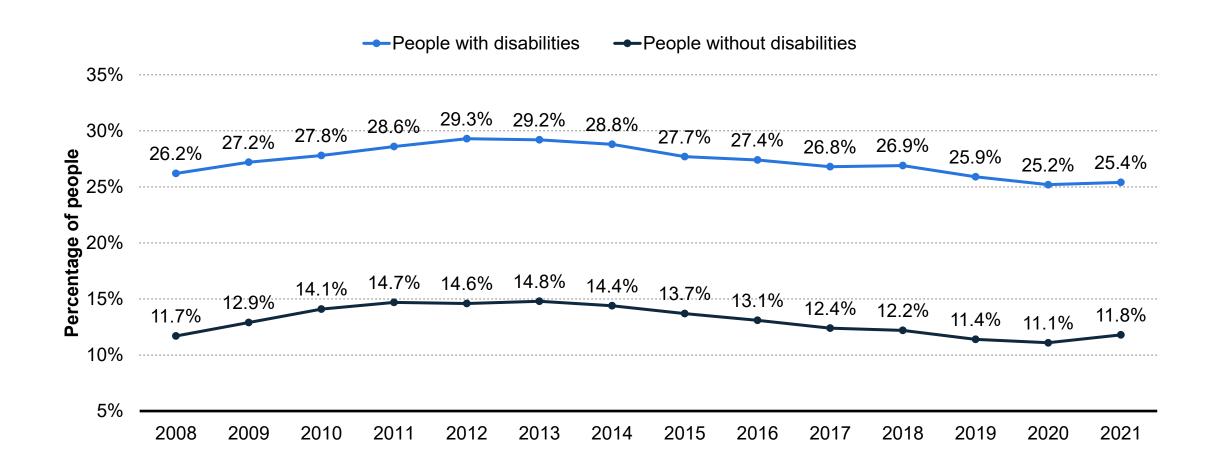


People with any type of disability are less likely to work (40%) compared to people with no disability (74.3%).

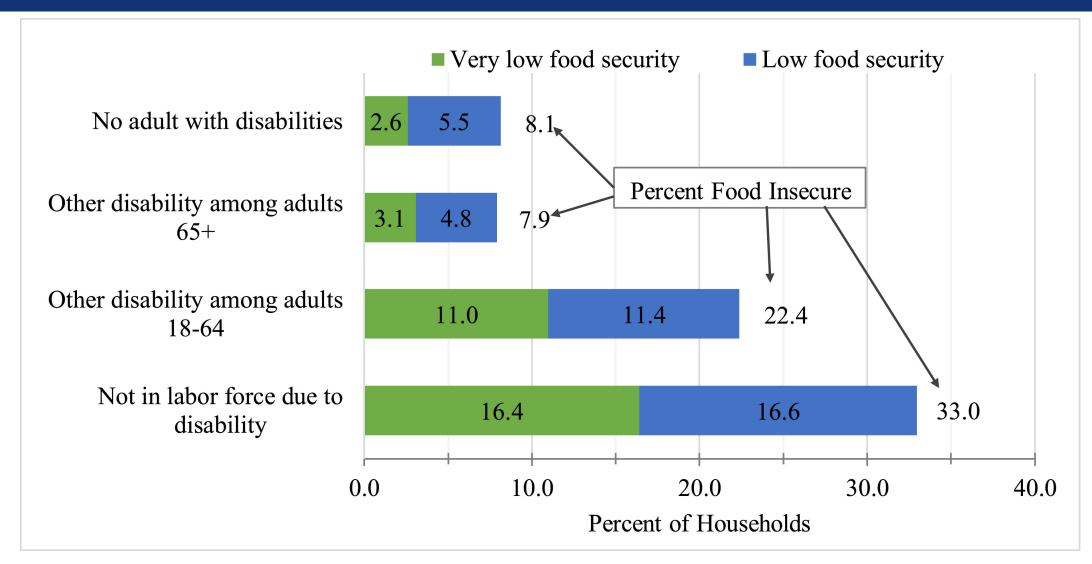
### Poverty Rate among People with and without Disabilities in the U.S. from 2008 to 2021



### **Economic Security: "Disability Tax"**

- The term "disability tax" refers to the extra financial burdens that individuals with disabilities often face due to the additional costs associated with their condition.
- These include expenses for specialized medical care, assistive devices, modifications to living spaces or vehicles for accessibility, transportation, personal care assistance, and other accommodations necessary for daily living.
- When disability tax is considered, the rate of disabled people living in poverty is estimated to rise to 35%.
- On average, a household with a member with a disability requires 29% more income to obtain a comparable standard of living to a household without disabled members.

#### Housing

- The affordable housing crisis especially impacts seniors and people with disabilities who need accessible housing so they can live in the community (Schaak et al., 2017).
- Supplemental Security Income (SSI) does not cover the average rent for a studio or one-bedroom apartment in any housing market across the United States (Diament, 2024).
- In 2024, the average one-bedroom rental cost in MA is 182% higher than monthly SSI payments. In Boston-Cambridge, it is 225% higher than SSI (Priced Out, 2023)
- On average, households with members who have any type of disability, as well as LTSS disabilities, live in poorer quality housing and neighborhoods. (Meschede et al., 2022)

#### **Transportation**

- Transportation barriers can present significant challenges for individuals with disabilities, limiting their ability to access essential services, employment opportunities, social activities, and healthcare.
- In many areas, accessible public transportation/paratransit options may be limited or unavailable.
- Only 27% of transit stations in New York City are accessible under ADA regulations.
- People with blindness or low vision, psychiatric disabilities, chronic healtl conditions, or multiple disabilities, experience more problems using public transportation.
- There are also documented disparities among public transit seekers who are female, Hispanic and/or Latino/Latina.

## "...physicians feel uncomfortable, untrained, unprepared, and their offices are also equally untrained and unprepared...

- 81% of medical students have no clinical training in disability care
- 75% of residents have no clinical experience in disability care
- 44% of Ob/Gyn clinics in 4 cities reported being unable to provide for people with mobility disabilities

## NIH designates people with disabilities as a population with health disparities

Designation, new research program and update to NIH mission are actions to ensure inclusion of people with disabilities.

Today, Eliseo J. Pérez-Stable, M.D., director of the National Institute on Minority Health and Health Disparities (NIMHD), designated people with disabilities as a population with health disparities for research supported by the National Institutes of Health. The decision was made in consultation with Robert Otto Valdez, Ph.D., the director of the Agency for Healthcare Research and Quality, after careful consideration of a report pdf delivered by an NIMHD advisory council, input from the disability community and a review of the science and evidence. A report pdf issued in December 2022 by the Advisory Committee to the (NIH) Director (ACD), informed by the work of the Subgroup on Individuals with Disabilities, explored similar issues faced by people with disabilities. The designation is one of several steps NIH is taking to address health disparities faced by people with disabilities and ensure their representation in NIH research.
