Workshop Objectives

- Understand the critical child infrastructure (i.e., the existing systems and networks of human and social services that serve children and youth) and how it functions (i.e., how services are delivered) before, during, and after a major federally declared natural or environmental disaster
- Understand the impact of disasters on children and youth that benefit from human and social services providers
- Understand the current gaps and future opportunities for supporting the coordinated delivery during and the restoration of services following major federally declared natural disaster
- Explore potential matrices for evaluating response and recovery efforts related to human and social services

Workshop Scope

- Children and youth ages 0-26
- People already receiving public supports (people with pre-disaster socio-economic deficit)
- Research and experiences related to federally declared natural disasters since Katrina
- Focus on disaster response coordination and transition to reconstitution of routine service delivery programs by state, local, tribal and territorial (SLTT) human, social services, and public health agencies.
- Promising practices, ongoing challenges, and potential opportunities for coordinated delivery and restoration of human and social services programs.

National Commission on Children and Disaster Recommendations: How Far Have We Come

- Recommendation 2.3: Federal agencies and non-Federal partners should enhance predisaster preparedness and just-in-time training in pediatric disaster mental and behavioral health, including psychological first aid, bereavement support, and brief supportive interventions, for mental health professionals and individuals, such as teachers, who work with children.
- 5.1 Disaster case management programs should be appropriately resourced and should provide consistent holistic services that achieve tangible, positive outcomes for children and families affected by the disaster.
- 6.1 Congress and Federal agencies should improve capacity to provide child care services in the immediate aftermath of and recover from a disaster
- 6.2 Congress and Federal agencies should improve capacity to provide child care services in the immediate aftermath of and recover from disaster...including codifying child care as an essential service of a governmental nature.
- 6.3 HHS should require disaster preparedness capabilities for Head Start Centers and basic disaster mental health training for staff.

- Psychiatric First Aid is now taught across the country. Organizations like Children's Bereavement Center of South Texas work with organizations like FEMA and the American Red Cross to provide support after a disaster.
- The Disaster Case Management program at ACF has now been operational for over 10 years.

- After Sandy it became a requirement for child care providers to have disaster plans.
- Child care is considered an essential service in some state such as New York.
- In 2009 Head Start published its first Emergency Preparedness manual.

Room for Improvement

- 7.1 Ensure that school systems recovering from disasters are provided immediate resources to reopen and restore the learning environment in a timely manner and provide support for displaced students and their host schools...and fund it
- 8.2 Ensure that State and local juvenile justice agencies and all residential treatment, correctional, and detention facilities that house children adequately prepare for disasters.

The Department of Homeland Security and the Department of Transportation are designated as the Co-Sector-Specific Agencies for the Transportation

The Department of Homeland Security is designated as the Sector-Specific Agency for the Commercial Facilities Sector, which includes a

diverse range of sites that draw large crowds of people for shopping, business, entertainment, or lodging.



Critical Manufacturing Sector

The Department of Homeland Security is designated as the Sector-Specific Agency for the Critical Manufacturing Sector.



Defense Industrial Base Sector

The U.S. Department of Defense is the Sector-Specific Agency for the Defense Industrial Base

Sector. The Defense Industrial Base Sector enables research, development, design, production, delivery, and maintenance of military weapons systems, subsystems, and components or parts to meet U.S. military requirements.
