Respiratory Protection During the COVID Pandemic

- Mask use initially discouraged by federal leadership
- Following endorsement by CDC in March, quickly politicized
- As impact of Stay-at-Home orders (economic, mental health, educational) became apparent, low economic impact nonpharmaceutical interventions became a primary option for curbing the pandemic



Community Use Of Face Masks And COVID-19: Evidence From A Natural Experiment Of State Mandates In The US


ABSTRACT State policies mandating public or community use of face masks or covers in mitigating novel coronavirus disease (COVID-19) spread are hotly contested. This study provides evidence from a natural experiment on effects of state government mandates in the US for face mask use in public issued by 15 states plus DC between April 8 and May 15. The research design is an event study examining changes in the daily county-level COVID-19 growth rates between March 31, 2020 and May 22, 2020. Mandating face mask use in public is associated with a decline in the daily COVID-19 growth rate by 0.9, 1.1, 1.4, 1.7, and 2.0 percentagepoints in 1-5, 6-10, 11-15, 16-20, and 21+ days after signing, respectively. Estimates suggest as many as 230,000-450,000 COVID-19 cases possibly averted By May 22, 2020 by these mandates. The findings suggest that requiring face mask use in public might help in mitigating COVID-19 spread. 



A team of economists lead by Jan Hatzius, chief economist at Goldman, makes the case that a national face-mask mandate could partially substitute for renewed lockdowns, as COVID-19 inflections flare up in a number of southern and western states in the U.S., that would "otherwise subtract 5% from gross domestic product." *Mask mandate is measured at announcement. Error bars represent a 95% confidence interval





Will Your COVID-19 Mask Protect You from Wildfire Smoke?

- People in the West now have to protect themselves not only from the novel coronavirus, but from wildfire smoke as well.
- Health experts say an N95 mask is your best bet for protecting yourself from both the novel coronavirus and wildfire smoke.
- Research shows KN95 masks are just as effective.



What Supports Does Public Health Need to Effectively Communicate?

- Readily available "respiratory protection 101" for baseline understanding of uses in variety of settings
- Context and target audience-specific information, available for "just in time" use and consistently delivered
- Clear explanation of the range of options (eg, avoiding the perfect being the enemy of the good)
- Materials adaptable for easy use and branding



Learnings from the Pandemic: Largest Natural Experiment in Promoting Respiratory Protection in World History

- Collateral benefit of mask wearing on other respiratory infections, especially those for which highly effective vaccines not available
- Could more widespread use of masks during subsequent annual influenza seasons reduce transmission and maintain "masks are useful" norms?
 - Such norms could be useful if/when another respiratory pandemic occurs
- Other uses to support norms
 - "Bad air" days due to smoke, air pollution
 - Commuter cycling
 - Common courtesy if going out with mild URI symptoms
