### Killing us softly...

• To paraphrase singer Roberta Flack, best known for the song *Killing Me Softly*, and who was diagnosed with ALS last year:

It's as though the insurance companies are looking right through us as if we weren't there.

# Overly restrictive durable medical equipment coverage



#### Covered... or not

- Covered, but not useful for me:
  - Semi-electric hospital bed
  - Manual Hoyer lift
- Not covered, and useful for me:
  - Fully electric hospital bed
  - Electric Hoyer lift

### Not covered, and essential for me

- Bathroom equipment
- Electric sit-to-stand lift



### Lack of financial support for caregivers

- Serving as the primary caregiver for a spouse who is progressing through ALS is a physically and emotionally draining job
- Additional support is necessary
- Thirty hours of weekly paid caregiving, which we have to pay for outof-pocket, exceeded 50% of my take-home pay each of the last 3 years
- Additional uncovered costs of ALS have left us drawing on our retirement savings for most non-medical living expenses

### Recommendation 1: Prior Authorization changes

- AMA letter to the Centers for Medicare & Medicaid Services in February 2023: urgently needed changes related to Prior Authorization in Medicare Advantage plans

- Adopt AMA recommendations on Prior Authorization immediately for all insurance plans

# Recommendation 2: durable medical equipment

- Acknowledge the heterogeneous presentation of ALS and rapid progression timeline
- Adopt faster and more flexible policies for Prior Authorization of durable medical equipment
- Account the needs of the individual patient and that patient's caregiving situation

# Recommendation 3: caregiving financial support

- Shortages of qualified caregivers
- ALS patients need loving care at home
- Broader and consistent support is needed to provide financial remuneration to family members who serve as caregivers of ALS patients

### ALS is not a hopeless disease!

- The policies and actions of insurance companies rob patients and families unnecessarily of time and hope that can allow us to focus on living.
- ALS can be made a more livable disease
