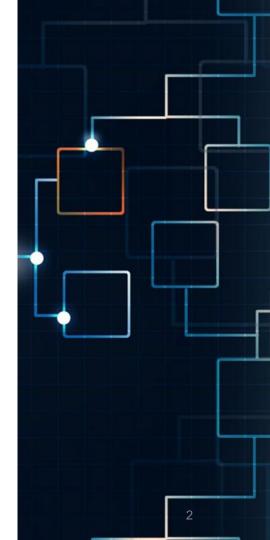

## Community Benefits Plan Elements

#### Community and Labor Engagement

 Meaningful engagement with community and labor partners leading to formal agreements with accountability to affected stakeholders

#### Investing in Quality Jobs

• Create good-paying jobs to attract and retain skilled workers and ensure workers have a voice on the job over decisions that affect them

## • Diversity, Equity, Inclusion, and Accessibility

• Equitable access to wealth-building opportunities (teaming, access to good jobs, business and contracting opportunities, etc.)

#### Justice 40

 Meet or exceed the objectives of the Justice40 initiative that 40% of total benefits from certain federal investments accrue to disadvantaged communities (not per project or per FOA)





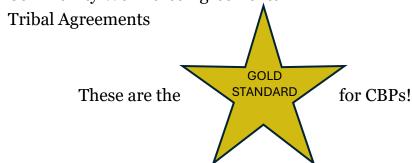
## Community Benefits Plans = Umbrella Term

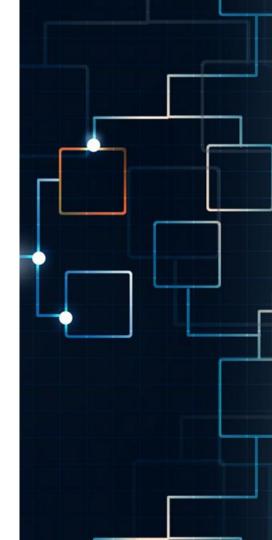

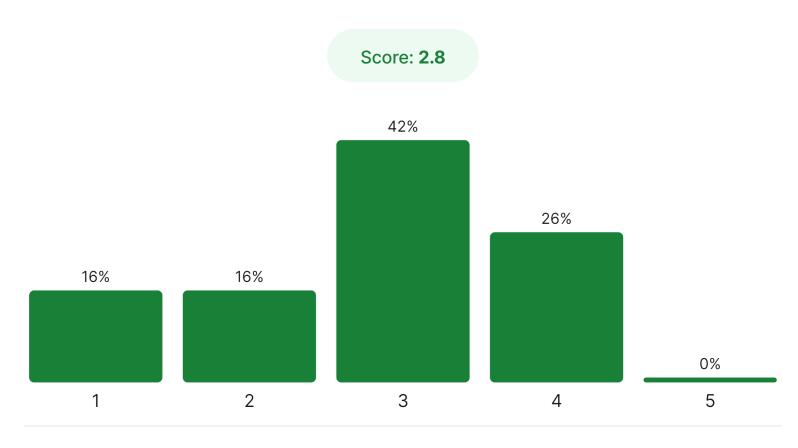

# What is a critical barrier to successful Community Benefits Plans?



#### How can DOE Improve the Community Benefits Plan process?

Making them accessible to the public to view

providing more examples of good plans.

Reducing barriers to making them happen by addressing resource gaps and other competing requirements.

Ensure that CBOs and other nonprofits are also included in CBA trainings and are knowledgeable in how to guide communities in the cba/cbp process.

**Training** 

Require risk (health and other) assessment and transparency

Pay communities to hire good lawyers to negotiate agreements, fund opposition to hubs, develop long term enforcement plan for agreements and fund enforcement

#### How can DOE Improve the Community Benefits Plan process?

Make transparent companies who are actively applying for grants and loans for early intervention (rather than waiting for an award/conditional commitment announcement); require companies to commit to negotiating a community benefits agreement including labor organizations (not just PLAs for construction jobs!!!), enviro groups, tribes, and other relevant local community organizations— the groups can take it from there on enforcement if the basic framework is pro

building community capacity to engage meaningfully (become acquainted with technical aspect, civic engagement b/c they haven't been, etc.) accountability and continued engagement from beginning, middle, to end community having a way to flag bad projects or when projects aren't meeting their commitments. need a connection between community and DOE

More information about CBPs submitted should be shared, including specific plans for engagement, which stakeholders are being engaged, what kinds of benefits are proposed, what opportunities/plans to make CBPs binding or transform into binding community benefit frameworks exist, and what modes for enforcement/oversight are included in the CBP, etc.

Stronger language on what is an acceptable CBA vs an unacceptable CBA. The language currently used is 'effective CBA' vs. 'ineffective CBA'. I would like to see a clearly defined scenario in which a rejected CBA stops the project from happening. If such a scenario doesn't exist, then I feel this conversation is about checking boxes of surface level community participation and not actually gathering and incorporating feedback from Community to center their needs.

#### How can DOE Improve the Community Benefits Plan process?

Create an enforcement arm to ensure paramount transparency, accountability, equity, and justice are centered in every phase of these projects, from ideation to implementation.

The process, as it stands, is applicant/awardee-driven. It nee

Allowing for flexibility in the budget for community benefits as the community needs may change from the proposal stage through completion of the project.ds to center community first.

Return to a mixed use portfolio of quantitative, and more importantly qualitative metrics for improvement. Reduce the moving target nature of it as well

Automate parts of it our hire technical assistance providers

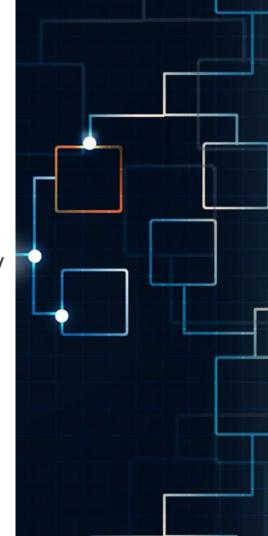

# Why should Community Benefits Plans matter to communities and developers?

Better Q: Why should DOE & EPA care about CBA's? Because you are tasked with protecting our natural resources, our public health, and stop abusers from exploiting our communities. People can care all day everyday, but if we don't have mechanisms of accountability from our government agencies, then community needs will always pale in comparison to the money behind these industries can throw to drown out/buy out community opposition.

For communities its likely their only way to hold developers accountable, guarantee benefits flow to impacted communities, and that there is a plan for the full lifetime and decommissioning of any projects. For developers, it would be nice if it mattered because it is the right thing to do, but ultimately it should matter because they are legally bound to their commitments.

CBP's should not be framed as needing to "matter". They should be contingent; a project should not move forward without an enforceable agreement. Additionally, labor and community have convergent needs but are inherently different and labor and community benefits should not be considered interchangeable

They'll only matter if they work.

# What could help build trust between communities and developers during negotiation processes?

Identify the points of leverage where the community can say no, can make more demands, and have our agencies be advocates for the public not just a 3rd party observers. DOE and other agencies must step up to be able to help hold these projects accountable and policies that protect the public.

It's not necessarily trust but rather trustworthiness and the framework of the negotiations.

Third party facilitation, real funding and capacity building for communities to participate in negotiation on equal footing

Empowering the community and requiring consent from impacted fenceline communities in order to move forward with any project. As it stands, this process empowers the industry and is being used as a tool to to show outreach irrespective of equitable, tangible public input.

#### Community Benefits Frameworks – Definitions

Private CBA: A legally-binding contract between a project developer and a set of community and/or labor stakeholders, setting forth community benefits to be provided if the proposed project moves forward; i.e. a "classic" or traditional CBA.

Compare with Community Benefits Plan (CBP).

Public CBA: A legally-binding contract between a project developer and a local public entity, setting forth community benefits to be provided if the proposed project moves forward; a.k.a. Host Community Agreement, Good Neighbor Agreement; may be a component of a Development Agreement.

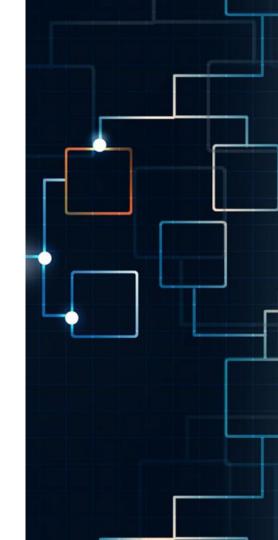
Project Labor Agreement (PLA): A specialized contract concerning construction labor, entered into by the local construction unions and a project developer, public entity, and/or prime contractor.

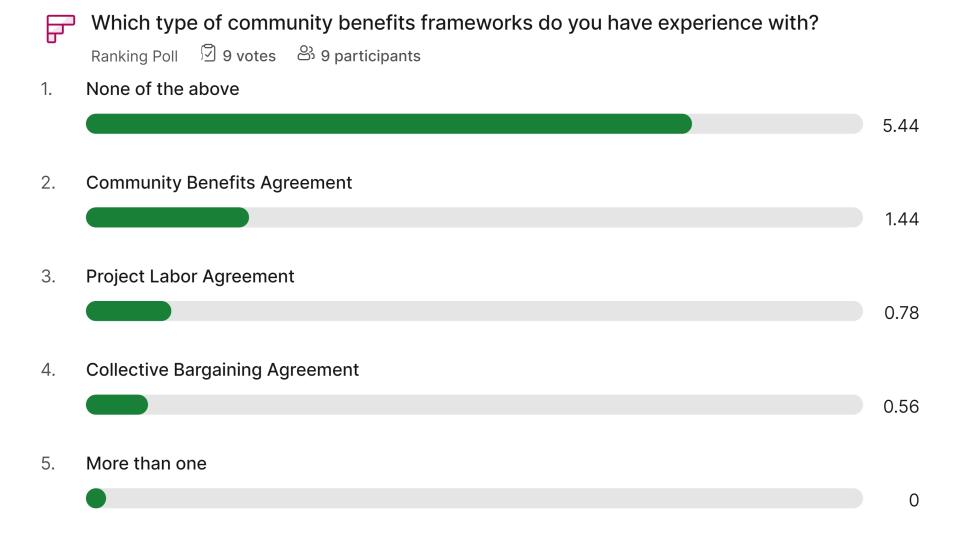
A Community Workforce Agreement (PWA) is a PLA that contains terms aimed at advancing targeted hiring, contracting, and equity goals.

Lessons Learned from Decades of Community Benefits Negotiation



#### What is a Fishbowl Conversation?

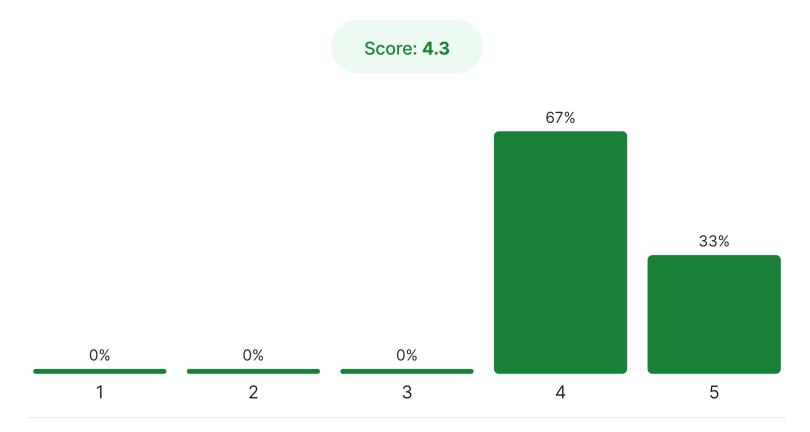

## What were your takeaways and reflections from Day 1?

CBAs have a long way to go before they are truly representing the will of community. Most people acknowledge the lack of enforcement, engagement, due-process and other variables that help community better negotiate.

Making CBPs and CBAs really work for communities will be challenging. The focus for me will be on finding ways to support community capacity.

My key takeaway message from Day 1 is that local elected representative play an essential role in developing Community Benefits Plans and Agreements. Community residents benefit the most when they elect officials that truly represent their needs. In reflection of Day, I would like to suggest new venues for awareness and education. It would be neat if the DOE, for example, built some sort of interactive website where concerned citizens may discover what and how different cities and towns are implementing federally-funded energy infrastructure projects. Each project could include descriptions for the challenges, actions, and practical results. It would be

wonderful to see how projects intersect with each other.

The importance of supporting communities in developing their own PRINCIPLES and coalitions and plans, as an overall strategy for engaging with developers and government on these massive projects - and doing this both locally and as multi-locale coalitions.

### What do communities need before they enter negotiations?

Agenda and a purpose and the needs of the community

Trust and an equitable position

critical insight and information, training and support in negotiation

Understanding of what the other parties will be doing. Decisions about what the community wants and expects from the other parties.

They need the DOE to use its power to create formalized processes that protect the community. DOE should be ensuring transparency, due process, equity and accountability. The idea that community must be the bottom line for all meaningful engagement is unreasonable and sets up unrealistic expectations for community groups to fail or be weak.

Support in understanding all the ways their lives will be impacted and the possible benefits. Support in sharing their stories with stakeholders, elected officials, and the media. And they need political education to understand the role of racial capitalism and its extractive nature.

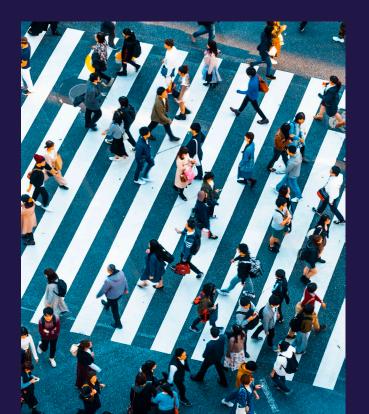

# How can long-term trust be built through community benefit frameworks?

simply engaging early and often

If current Community Benefits do not allow for a community to reject a project and say, "No". Then that needs to be included on the list of ways to build trust. Too much of the focus is emphasized on how to appeal to industry vs ensuring the protection and growth of the public interest.

Companies and government agencies need to LISTEN to community groups as experts on needs. These same stakeholders need to negotiate in good faith with the community and not use their political and economic power to punish communities but make it possible for them to prosper with them. It has to be grounded in equity and justice not just profit and power. Equity and justice is good for the country as a whole!

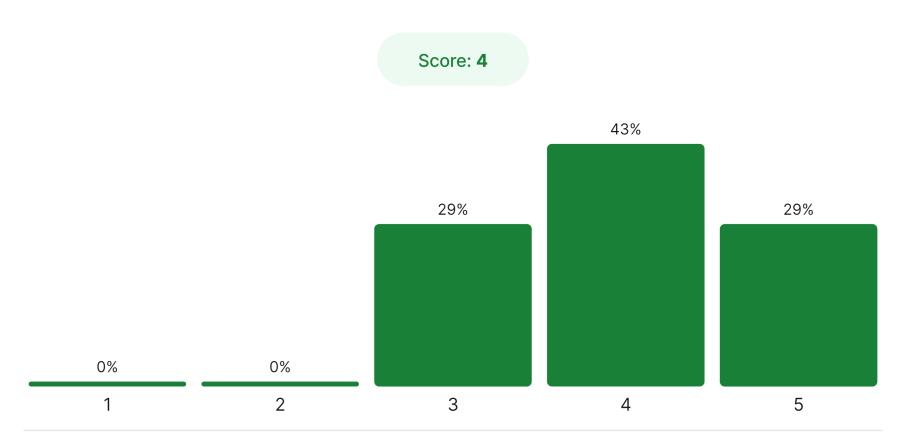

# What is a key takeaway you can't wait to share with your colleagues and communities?

Communities can have multiple cbas for different groups in a community.

CBPs and CBAs will only deliver if communities have the capacity to meaningfully engage. And only if government, business, finance, philanthropy, and finance increase their community focused capacities.

How to get help in accessing development information before its too late

The opportunity to ally with communities (as nurses) in energy project related community benefit.

That there are people at agencies that believe in equity and want to do the hard work of strengthening civic and community org infrastructure.

We are not alone in experiencing these obstacles but per are on the right track

From where you sit, in what way can connection and capacity be built for federal and community actors to work for community benefits?
