

our field is heavily tilted toward computational methods, social psych experiments, and legal analysis


many overlooked and understudied platforms

leave-up or take-down is the fixation of social media policy debates (douek 2020)

narrow genre of debunking in Global South is a product of platforms' investments in fact-checking (Lelo 2024)

moral panics about the "social media-brainwashed" can be exploited by illiberal leaders, perpetuate anti-poor sentiments, and alienate voters

#### My ethnographic work: from content to process regulation

'Duterte trolls' in the Philippines are not the brainwashed, uneducated, poor voters in rural areas

there's a classed hierarchy of paid operatives: public relations strategists, influencers, fake account operators

trolling is not a full-time job; it's a side hustle to make ends meet

journalistic investigations often expose low-level workers but fail to hold accountable political and commercial elites and the complicit industries of advertising, PR, digital marketing

# Centering Global South advocacies? Can we access the same toolkits as the Global North: ad libraries, transparency audits, local platform policy officers, legal support? (Free Press, 2024) Global South tech activists are often overlooked in

Global South tech activists are often overlooked in global advocacies, e.g., 58 organizations challenged UNESCO platform governance recommendations as "rubber stamping local overregulation" via #PushbackUNESCO (2023)

Global South election coalitions have higher number of participating organizations but all financially incentivized to use same database, tools, and strategies (Lanuza et al, forthcoming)



# 4- Blueprint for Southto-South Knowledge Exchange


Global South as sites of digital innovation not of dystopia (Arora 2020).

Ways of working in the Global South are more culturally proximal and resonant vs replicating tools from the Global North (Wasserman & Madrid-Morales 2022)

Reflexivity in collaboration, citation, knowledge creation (Medrado & Verdegem 2024) vs co-option of indigenous tech activism (Lehuede 2024)

Designing "custom built disinfo solutions" begins with critique of unjust global governance structures and extractive systems of knowledge creation (Lanuza et al, forthcoming)


