
### ERIC's mission:

Help state and local election officials improve the accuracy of their voter rolls, register more eligible citizens, reduce costs, and improve efficiencies in the voting process.


### **ERIC Overview**



| Report Type                       | Records Sent |

# September, 2017 cumulative statistics: List Maintenance

| Report Type   | 2017<br>Summary | Total<br>Records |
|---|-----------------|------------------|
| In-state movers/updates More recent activity in DMV record          | 1,652,201       | 5,527,933        |
| Cross-state movers  More recent registration/license in other state | 722,443         | 1,747,491        |
| Deceased Appears on national death index                            | 28,548          | 199,594          |
| In-state duplicates Duplicate voter records                         | 50,438          | 141,203          |
| TOTAL   | 2,453,630       | 7,616,221        |

## Cost Savings and Efficiencies with ERIC



#### Shared costs:

- NCOA
- Social Security Death List

#### King County (Seattle), Washington:

 33% reduction in undeliverable ballots

#### Minnesota:

- \$7,500 savings for shared services
- Fewer Election Day registrations

### **Privacy & Security**



- Reports are to be used only for VR purposes
- Reports must be kept confidential
- State must immediately disclose unauthorized release of data
- SSN, DLs & DOBs are anonymized via one-way hash (2x)
- Information Security
   Management Plan and a
   comprehensive set of security
   policies all guided by a
   comprehensive risk matrix.
