
# The Autopsy Initiative

A 2021 study published by *The Lancet* revealed that from 1980 to 2018, over half of police - related deaths in the United States have been unreported and misclassified.





#### **AUTOPSY INITIATIVE OBJECTIVE**

- We offer **free autopsy services** to families who have lost loved ones due to an in-custody death.
- Our initiative is supported by a team of **board certified forensic pathologists** who conduct second autopsies with objectivity, efficiency, and diligence to provide families with their loved one's cause of death diagnosis.
- Second autopsies provide transparency for families.
- In the medical field, obtaining **second opinions** are highly valuable for ensuring accuracy and maintaining objectivity.

# Definition of In -Custody Death:

A death that occurs during arrest, apprehension, pursuit, or while incarcerated.

#### **AUTOPSY INITIATIVE CRITERIA**

#### Criteria for Acceptance:

- The death must satisfy the KYRC definition of an in-custody death.
- The decedent's representative (next of kin, spouse, children, or parents) must provide **consent** for the autopsy.
- There must be a **reasonable likelihood** of determining a definitive cause of death diagnosis.
- The case must be **time-sensitive** and within a **reasonable timeframe** postmortem.
- Generally, **no embalming, burial, or cremation** has taken place prior to the autopsy.
- The remains should not be in advanced stages of decomposition.
- Advanced decomposition may also **limit the feasibility** of conducting a thorough and effective autopsy.

#### Forensic Pathologist Coordinator:

- Our Pathologist Coordinator evaluates
   all cases to determine the reasonable
   likelihood of obtaining an accurate
   cause of death diagnosis.
- The Coordinator reviews the
   information from the autopsy request
   form, prescreening-questionnaire, and
   makes a recommendation based on the
   the specifics of each case.
- Our Operations Manager consults with the family's selected funeral home regrading status of decomposition to report to our Coordinator.

# Independent Second Autopsy

#### Performed by Experts:

• Conducted by board-certified forensic pathologists from our panel.

#### Nationwide Coverage:

• Services available across the country.

#### Timeline:

• To ensure optimal results, the autopsy should be performed within 2-3 weeks postmortem.

# Preliminary Findings

- Direct consultation with pathologists who conducted the autopsy.
- Helps families and their attorneys with immediate insights into findings and observations



# Issuance of Final Autopsy Report


- Examination of the initial autopsy report from the Medical Examiner/Coroner.
- Review of additional relevant evidence, including medical records, body cam footage, and photos.
- A final autopsy report is provided, with a detailed cause of death diagnosis based on thorough analysis.



# SELECTION OF PATHOLOGIST AND ARRANGEMENTS FOR TRANSPORTATION

#### Geographical Considerations:

• Pathologists are selected based on their **proximity** to the location of the death and their **availability**.



#### Transportation:

- Pathologists performing the second autopsies must be licensed in the state where they perform the autopsy.
- If the individual's death did not occur in the state where one of our pathologists is licensed, the deceased must be transported to the state where the pathologist is licensed.

#### Costs:

- Our Initiative covers all
   transportation costs associated with
   the performance of the autopsy.
- Average Cost w/ Transport: \$13,600





## PATHOLOGIST REQUIREMENTS

#### Interview Process

Conducted with our team and the Forensic Pathologist Coordinator.

#### Code of Ethics


 Pathologists must adhere to the College of American Pathologists Principles of Ethical and Professional Conduct.

#### Autopsy Procedure

 A complete autopsy includes a thorough external and internal examination of the body, anterior and posterior forensic neck dissection, posterior subcutaneous dissection, and full inspection and photography of all body cavities.


#### Toxicology and Histology

 Toxicology and histology tests should be performed on all unembalmed bodies at the discretion of the selected pathologist.






## COMPLETED CASES: DISCREPANCIES



6 out of 20 completed cases had a difference in cause of death diagnosis



12 out of 20 completed cases had a discrepancy, inaccuracy, or suspicious circumstance present



#### MAJOR DISCREPANCIES

#### First Example

The medical examiner ruled the individual's death as a natural cause of dehydration/bronchopneumonia;
Our pathologist who performed the individual's second autopsy ruled death as asphyxia by manual strangulation.

## Second Example

Bullet was found in the individual's body during the performance of the second autopsy.

#### Third Example

Deceased's family was told that a first autopsy was performed. Our pathologist who was supposed to perform the second autopsy performed a first autopsy; no incision marks found on the individual's body indicating no first autopsy was performed.

**Note**: This has occurred 3 times with our cases




