

USACE HIGHLIGHTS



- WRDA 2020 (Implementation Underway)
 - Record number (46) Chief's Reports paves the way for \$10B in projects
 - Changes Inland Waterways Trust Fund formula 50/50 to 65/35%
 - Directs USACE to update guidance related to sea level rise, invasive species, economically disadvantaged communities
 - Amends existing authorities related to USACE study and project deauthorization processes to address \$98B backlog
 - Encourages nature-based infrastructure solutions and offers more flexibility in identifying long-term solutions for repetitive flooding
 - Allows greater access to the \$10 billion balance in the Harbor Maintenance Trust Fund
- Congress allowing new Community Project Requests (CPR) process in development

INFRASTRUCTURE INVESTMENT AND JOBS ACT (IIJA)



For the CW program, the bill provides a total of \$17.1 billion

Investigations \$150 million – remains available until expended

Construction \$11.615 billion – remains available until expended; can be spent on 'new

starts'; waives 902; federal share of DMDFs are derived from general

treasury; establishes certain reporting requirements

Of the Account \$1.5 billion shall be used for major rehabilitation, construction, and related activities for rivers and

harbors

Of which And up to

\$250 million shall be to undertake work at remote and subsistence harbors

\$250 million may be for federal breakwater/jetty projects

Of the Account

\$2.5 billion for inland waterways projects; waives need to cost share from IWTF

O&M \$4.0 billion – remains available until expended;

Sums necessary to cover the Federal share of eligible O&M costs for coastal harbors and channels, and for inland harbors shall be derived from the general treasury; establishes certain reporting requirements
