Statement of Task

An ad hoc study committee will use a workshop-based study approach to examine how collaborative platforms addressing multidisciplinary questions in food and agriculture can be constructed in ways that deepen the impact of the Land-Grant system in generating knowledge and its applications. The study will identify the essential ingredients of platforms that support high-quality science, permit broad participation and that give equitable access to platform resources to participants across the Land-Grant college and university system, including historically Black colleges and universities and other institutions.

Building on the work of the National Academies' Committee to Enhance Coordination and Collaboration among Land-Grant Colleges and Universities, the study will examine examples of existing multi-institutional collaborative platforms to define platform elements that are conducive to producing broad impacts and that enhance team science, asset sharing, capacity building, and the generation of translational knowledge. The committee will also explore specific ways that collaborative platforms explicitly connect education, research, and extension, and examine what is needed to effectively assess, capture and articulate the impacts of the platform and its work, including economic impacts, to public and private stakeholders.

The committee will organize a multi-day workshop highlighting the essential ingredients found in different existing collaborative platforms and engage stakeholders in an exercise to envision the design of new platforms to address key problems in the food and agricultural system. Based on its preliminary work and stakeholder discussions at the workshop, the committee will prepare a brief report recommending an architecture for collaborative platforms that generate stakeholder and public awareness of their value to society, including economic value, through their contributions to research, education, and knowledge transfer.

Committee Biographies

Stephen (Steve) Yanni (Chair) serves as Land Grant Director for Bay Mills Community College (BMCC), a Tribally Controlled College located in Eastern Upper Michigan, where he oversees BMCC's efforts as a 1994 Land Grant Institution. He has been working with the Bay Mills Indian Community in various capacities for 25 years. Current areas of focus include: continued development of BMCC's Waishkey Bay Farm as a teaching, research, and incubator facility focusing on sustainable agriculture and food sovereignty that is consistent with traditional Anishinaabek values; development of curriculum in sustainable agriculture, food sovereignty, and health promotion that is grounded in Anishinaabek lifeways; community development and health promotion efforts; overseeing BMCC's Mukwa Health and Fitness Education Center; and assisting with the evolution of the Michigan Inter-Tribal Land Grant Extension System (MILES). Yanni also serves as BMCC's liaison with the Higher Learning Commission, coordinates research efforts by and with BMCC, and represents 1994 institutions on the Association of Public and Land-Grant University's Board on Agriculture Assembly Policy Board of Directors. Prior to working with Bay Mills, he was a faculty member for 18 years at Lake Superior State University and worked for Michigan State University as a County Extension Director. Yanni received a Ph.D. from Michigan State University.

Anthony (Tony) Boccanfuso has led University-Industry Demonstration Partnership (UIDP) since 2007, serving as executive director when UIDP was convened under the National Academies of Sciences, Engineering, and Medicine and since 2015, when the partnership became an independent nonprofit, as president and CEO. In his 30-plus-year career in research and commercialization roles, he has managed administrative, programmatic, and strategy initiatives for academic and government organizations (including the National Institutes of Health and National Science Foundation, NSF) and also worked in the private sector, where he served as a consultant to major research organizations seeking to maximize their work's impact. Boccanfuso is part of the leadership for the Engineering Research Visioning Alliance (ERVA), an NSF-funded initiative with a mission to identify and develop new engineering research directions and catalyze high-impact research that benefits society. Boccanfuso received a B.S. in chemistry and political science from Furman University and a Ph.D. in inorganic chemistry from the University of South Carolina.

In his role at UIDP Boccanfuso advocates for increasing the impact from academic-corporate partnerships.

Mahmud Farooque is the Associate Director of the Consortium for Science, Policy and Outcomes, and a Clinical Professor in the School for the Future of Innovation in Society at Arizona State University. Previously, he held research leadership positions at the New York Academy of Sciences, City University of New York, Northwestern University, and Purdue University. He is among the world's leading experts in participatory technology assessment (pTA), a reflexive, adaptable, and scalable method for engaging communities, stakeholders, and publics in social appraisal of science and technology. His expertise draws from science and technology studies, science of science, public administration, public engagement, and deliberative democracy. Farooque leads the Expert and Citizen Assessment of Science and Technology (ECAST), a distributed network dedicated to research and applications of pTA. Since 2010, with support from public agencies and philanthropic organizations, he has overseen pTA processes on issues such as biodiversity, planetary defense, solar geoengineering, autonomous vehicles, human gene editing, nuclear waste management, and carbon dioxide removal. He serves on the editorial board of the Journal for Technology Assessment in Theory and Practice. Farooque received a PhD. in public policy from George Mason University and an MPA from Syracuse University. He currently serves on the National Academies Board on Environmental Studies and Toxicology.

Farooque provided testimony, "A Research Infrastructure for Maximizing Public Value of Science," before the U.S. House of Representatives Committee on Science, Space, and Technology Subcommittee on Research and Technology, May 6, 2021, Hearing on "National Science Foundation: Advancing Research for the Future of U.S. Innovation Part II."

Michael Rios is vice provost of public scholarship, a professor in the Department of Human Ecology, and faculty member in the Community Development, Education, and Geography graduate programs at the University of California, Davis. Rios' scholarship focuses on institutional transformation in higher education, community engagement, community-driven placemaking, and cultural citizenship. He has authored or co-authored more than twenty journal articles and book chapters and has co-edited several books including Diálogos: Placemaking in Latino Communities and Community Development and Democratic Practice. Recent research focuses on faculty motivations for pursuing engaged scholarship, graduate training in engaged research, and institutional supports for epistemic inclusion. He was inducted into the Academy of Community Engagement Scholarship in 2024 and is co-founder of the University of California Community Engagement Network. Currently, he is serving a three-year term on the executive committee of the Association of Public Land-grant University's Commission on Economic and Community Engagement. Rios received an M.Arch. in architecture and an M.C.P. in city planning from the University of California, Berkeley, and a Ph.D. in political geography from the Pennsylvania State University.

Staff Biographies

Robin Schoen is the Director of the Board on Agriculture and Natural Resources (BANR) of the congressionally chartered, not-for-profit National Academies of Science, Engineering, and Medicine. BANR is the program unit of the Academies responsible for bringing scientific experts together around issues related to food and agricultural production, forestry, wildlife, and the use of land, water, and other natural resources, in response to requests from Congress and the federal agencies, states, and the private sector. BANR's recent work is diverse and includes a study to identify science breakthroughs to advance food and agricultural research by 2030; a review of the citrus greening research portfolio of the Florida citrus growers; and a technical document of the nutrient requirements of poultry, among other activities. Robin joined BANR in 2005 from the Academies' Board on Life Sciences and Office of International Affairs, and before that, the National Institutes of Health. A native Washingtonian, Robin received a B.S. in biology and chemistry from Frostburg State College, Maryland, and an M.A. in Science and Technology Policy from George Washington University.

Susana Rodriguez, Ph.D., is a program officer with the Board on Animal Health Sciences, Conservation, and Research. She supports the Standing Committee for Care and Use of Animals in Research. She is project staff for the Committee on the Review and Transmission and Geographic Spread of Chronic Wasting Disease in U.S. Cervid Populations and is collaborating on a cross-divisional project addressing the synthetic opioid addiction and overdose crisis in the United States. Other National Academies studies she supported include a consensus study on nonhuman primate models in biomedical research. Prior to joining the National Academies in 2022, Dr. Rodriguez worked as a Senior Research Specialist at the Center for Metabolism and Obesity Research at the Johns Hopkins School of Medicine (JHSOM) investigating the molecular mechanisms that cells and animals utilize in response to nutritional and metabolic cues. For her postdoctoral work at JHSOM in the Department of Physiology, she characterized the metabolic functions of a novel and highly conserved family of secreted proteins that are altered by nutritional, metabolic, and disease states in the liver, kidney, and heart. Before starting her postdoctoral research, Dr. Rodriguez worked as an Evaluation Research Assistant for BioEYES, a science education program at the Carnegie Institution for Science, Department of Embryology, Dr. Rodriguez received her Ph.D. in Biological Chemistry from the JHUSOM. Her doctoral research focused on developing chemicalgenetic tools to control the spatial and temporal expression of metabolic enzymes involved in regulating skeletal muscle metabolism in mammalian cells. For her postbaccalaureate research, she conducted fetal glycogen metabolism research in the Department of Endocrinology at Boston Children's Hospital. She earned her B.A. in Chemistry with a minor in Biology from California State University Dominguez Hills.

Malia Brown, is the Senior Program Assistant on the Board of Agriculture and Natural Resources. She has been with the National Academies for about two years and has supported multiple projects for the Board. She earned a bachelor's degree in Biology with a minor in the Spanish Language from Towson University. Malia is currently enrolled as a master's student at Johns Hopkins University, where she studies Environmental Science and Policy.

Speaker Biographies

Aurbach, Elvse is a public engagement and research impacts leader. She specializes in translating research into useful tools for practice, building effective training and capacity-building programs, and developing frameworks that synthesize scholarship and practitioner knowledge to help university and public engagement systems evolve. She currently serves as Assistant Provost for University Outreach and Engagement at Michigan State University. Aurbach previously held a variety of roles supporting public engagement in higher education, most recently as Director for Public Engagement & Research Impacts in the University of Michigan's Office of Research, where she led strategy and a team that supported university faculty in their public engagement efforts. She was a Civic Science Fellow with the Association of Public and Land-grant Universities, where she led the Modernizing Scholarship for the Public Good initiative, offering guidance to public research universities on ways that they can support scholars and advance public impact research and other forms of public engagement, and diversity, equity, and inclusion. Aurbach worked with the Center for Academic Innovation as Public Engagement Lead, overseeing the center's role in a Presidential strategic focus area on faculty public engagement. She also led a number of projects locally and nationally to improve science communication and public engagement. These include a NASEM Workshop on institutionalizing engaged research, including developing and teaching communication courses in person and online, Co-Bossing with Nerd Nite Ann Arbor, and co-founding and directing RELATE, a science communication and public engagement organization. Aurbach was a NSF Graduate Research Fellow, a finalist for the AAAS Early Career Award for Public Engagement with Science, and an ARIS Fellow. She holds a PhD in neuroscience.

Bishop, Matthew L. serves as interim vice president for Public Service and Outreach at the University of Georgia, where he provides institutional leadership for UGA's outreach, engagement and economic development mission, which includes eight diverse units: Carl Vinson Institute of Government, J.W. Fanning Institute for Leadership Development, UGA Center for Continuing Education & Hotel, Archway Partnership, State Botanical Garden of Georgia, Marine Extension and Georgia Sea Grant, the state's 18 Small Business Development Centers, and the Office of Service-Learning (co-led with the vice president for Instruction). The annual economic impact of Public Service and Outreach to the state of Georgia exceeds \$505 million. In his role as vice president, Bishop is responsible for training, technical assistance, continuing education, and applied research programs that develop leaders, create new and support existing small businesses, advise governments on how to be more efficient, protect the environment, revitalize downtowns, and bring economic development opportunities to communities throughout Georgia. In addition, Bishop works to connect UGA's 19 schools and colleges with PSO's extensive network of expertise in leadership, government, business, service and nonprofits throughout the state to enrich the teaching and research missions of UGA and to provide UGA students with real-world experiences. Previously, Bishop served as associate vice president for Public Service and Outreach, 11 years as director of the J.W. Fanning Institute for Leadership Development, and operations coordinator for the Archway Partnership, where he was instrumental in expanding Archway from three to eight communities. His UGA career also includes serving as faculty at the Fanning Institute and Carl Vinson Institute of Government. Before joining UGA, Bishop served as associate director of the Governor's Rural Development Council and as regional resource coordinator for the Georgia Department of Community Affairs. Bishop earned a B.A. in political science from Presbyterian College and an M.P.A and Ph.D. in public administration from the University of Georgia.

Campbell, Susanna is the Provost Associate Professor in the Department of Foreign Policy and Global Security, School of International Service (SIS) and Director of the Research on International Policy Implementation Lab (RIPIL) at American University. Her research examines research-to-policy translation as well as interactions between international and domestic actors in fragile and conflict-affected contexts, addressing debates in the state building, peacebuilding, peacekeeping, international aid, global governance, and foreign policy literatures. She uses mixed-method research designs and has conducted extensive fieldwork in conflict-affected countries, including Burundi, Democratic Republic of Congo, Nepal, Sudan, South Sudan, and East Timor. Her research

has been supported by awards from the Carnegie Corporation of New York, US National Science Foundation, Humanity United, the Swiss National Science Foundation, the Swiss Network for International Studies, the United States Institute of Peace (USIP), the Swedish and Dutch governments, and the United Nations. Prof. Campbell's first book, Global Governance and Local Peace (Cambridge University Press, 2018), argues that because global governance actors are accountable to external stakeholders, seemingly "bad behavior" by country-based staff is necessary for local peacebuilding performance. It was shortlisted for the 2020 Conflict Research Society Book of the Year Prize and featured as one of the 2018 top picks for engaged scholarship by Political Violence @ a Glance. She is finishing a co-authored second book, Aid in Conflict, that explains how and why aid donors engage differently with war-torn countries. Her work has also been published or is forthcoming with American Journal of Political Science, Cambridge University Press, Columbia University Press, Foreign Affairs, International Studies Review, International Peacekeeping, Journal of Global Security Studies, Journal of Politics, Oxford University Press, Political Research Quarterly, Review of International Organizations, among others. Prior to graduate school, she worked for the United Nations, International Crisis Group, and the Council on Foreign Relations. She received her PhD from Tufts University and was a Post-Doctoral Researcher at Columbia University's Saltzman Institute of War and Peace Studies and The Graduate Institute in Geneva. Her PhD research was supported by a USIP Peace Scholar Fellowship and a Tufts Provost Fellowship. In 2018, she received AU's School of International Service Scholar-Teacher of the Year Award and, in 2021, the Outstanding Contribution to Fostering Collaborative Scholarship award. In 2023 she was a Fellow at the Woodrow Wilson International Center for Scholars and, in 2024, was awarded the Provost Associate Professor title by American University's Provost. Her scholarship has had an impact on the policies of the United Nations, International Non-Governmental Organizations, private foundations, and governments.

Chapotin, Saharah Moon is the executive director of the Foundation for Food & Agriculture Research (FFAR). Dr. Saharah Moon Chapotin leads the foundation in support of its vision - a world in which pioneering, collaborative science provides every person access to affordable, nutritious food grown on thriving farms. Chapotin is a plant scientist passionate about the role of agriculture and research in solving today's challenges. She is committed to building partnerships in support of this vital science. Chapotin offers decades of experience bringing the best of global science on issues ranging from crop breeding and animal diseases to food security, nutrition and agricultural productivity to her leadership at FFAR. Prior to joining FFAR in August 2022, Chapotin held roles across the government, including at the U.S. Department of Agriculture and the U.S. Botanic Garden, where she served as executive director. Chapotin also worked at the U.S. Agency for International Development, where she served as a deputy assistant administrator and worked to advance the U.S. government's global hunger and food security initiative, Feed the Future. Earlier in her career, Chapotin completed fellowships at Iowa State University, the National Academies and the American Association for the Advancement of Science working on issues of scientific communication, national security and agricultural biotechnology. She further conducted research on forest ecology and canopy biology throughout the U.S., Madagascar and Costa Rica. Chapotin holds a bachelor's degree in biology from Stanford University and a doctorate in plant physiology from Harvard University.

Colletti, Joseph is the Senior Associate Dean Emeritus for the College of Agriculture and Life Sciences at Iowa State University and, the associate director of the Iowa Agriculture and Home Economics Experiment Station. He has served in those positions since 2006. He oversees budgets, research and personnel for the college and Experiment Station. He also facilitates research planning and activities related to the bioeconomy and, in particular, development of Iowa State's BioCentury Research Farm. Colletti joined Iowa State in 1978 as a member of the forestry department faculty. He served as interim chair of the Department of Natural Resource Ecology and Management from 2004-2005. His research areas focus on the economics of agroforestry, management of streamside buffer systems on farmland and biorenewable resources. He has taught undergraduate and graduate courses in forestry and natural resources economics, decision-making and management. Colletti earned his doctorate and master's degree in forest economics from the University of Wisconsin, Madison. He earned his bachelor's degree in forestry at Humboldt State University.

Crowley, Max is a prevention scientist investigating how to optimize investments in healthy development and well-being. This work sits at the intersection of social policy, prevention science and public finance. His program of research is motivated by a desire to increase the use of cost-effective, evidence-based preventive strategies to improve the lives of children and families. To accomplish this, his work aims to (1) strengthen methods for benefit-cost analyses of preventive interventions, (2) optimize prevention strategies' impact and (3) develop best practices for how to translate these investments into evidence-based policy. In this manner, he seeks to not only understand the costs and benefits of prevention but aim to develop better interventions and encourage them to be disseminated widely. Dr. Crowley is accepting graduate students and postdoctoral trainees for the upcoming academic year.

Dostilio, Lina is the vice chancellor for external relations at the University of Pittsburgh, where she acts as deputy and strategic adviser to Senior Vice Chancellor for External Relations Kevin Washo. Fitzgerald, Colleen M. is the Vice President for Research and Creative Activity at North Dakota State University (NDSU), a public land-grant Carnegie R1 research institution. NDSU had record-breaking research growth in FY23, including \$190.3 million in research expenditures and double-digit growth at multiple federal agencies. Under her leadership, NDSU has won prestigious awards, including a National Science Foundation (NSF) I-Corps Hub focused on the Great Plains region and an inaugural NSF Regional Innovation Engine award for a statewide, multi-sector partnership in AgTech - one of only 9 Engines nationwide. His current work includes serving as Associate Department Chair for OLPD and as Director of the International Center for Research on Community Engagement. The MILES is the next step in building the foundation for a seamless, integrated, and intentional Land Grant System in Michigan serving all Michigan Tribal Nations Tribal Colleges, and communities. She currently sits on Tribal Council for LTBB. She has also worked as an Child Protective Services Worker, as an associate Child Welfare Commissioner and was elected three times as LTBB's Speaker of the Annual Community Meeting. Purpose

To prohibit discrimination, harassment, and bullying for all participants in National Academies activities.

Applicability

All participants in all settings and locations in which the National Academies work and activities are conducted.

Preventing Discrimination, Harassment, and Bullying: Policy for Participants in National Academies Activities

The National Academies of Sciences, Engineering, and Medicine (National Academies) are committed to the principles of integrity, civility, and respect in all of our activities. We look to you to be a partner in this commitment by helping us to maintain a professional and cordial environment. All forms of discrimination, harassment, and bullying are prohibited in any National Academies activity. This policy applies to all participants in all settings and locations in which the National Academies work and activities are conducted, including committee meetings, workshops, conferences, and other work and social functions where employees, volunteers, sponsors, vendors, or guests are present.

Definitions

Discrimination is prejudicial treatment of individuals or groups of people based on their race, ethnicity, color, national origin, sex, sexual orientation, gender identity, age, religion, disability, veteran status, or any other characteristic protected by applicable laws. **Sexual harassment** is unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature that creates an intimidating, hostile, or offensive environment.

Other types of harassment include any verbal or physical conduct directed at individuals or groups of people because of their race, ethnicity, color, national origin, sex, sexual orientation, gender identity, age, religion, disability, veteran status, or any other characteristic protected by applicable laws, that creates an intimidating, hostile, or offensive environment.

Bullying is unwelcome, aggressive behavior involving the use of influence, threat, intimidation, or coercion to dominate others in the professional environment.

Reporting and Resolution

Any violation of this policy should be reported. If you experience or witness discrimination, harassment, or bullying, you are encouraged to make your unease or disapproval known to the individual at the time the incident occurs, if you are comfortable doing so. You are also urged to report any incident by:

- Filing a complaint through the National Academies Complaint Intake Form (https://nas.hracuity.net/webform/index/a5ed0226-f5e5-4da4-be0d-1daf8976f594), and/or
- Filing a complaint with the Office of Human Resources at 202-334-3400 or hrservicecenter@nas.edu, or
- Reporting the incident to an employee involved in the activity in which the member or volunteer is participating, who will then file a complaint with the Office of Human Resources.

Complaints should be filed as soon as possible after an incident. To ensure the prompt and thorough investigation of the complaint, the complainant should provide as much information as is possible, such as names, dates, locations, and steps taken. The Office of Human Resources will investigate the alleged violation in consultation with the Office of the General Counsel.

If an investigation results in a finding that an individual has committed a violation, the National Academies will take the actions necessary to protect those involved in its activities from any future discrimination, harassment, or bullying, including in appropriate

circumstances the removal of an individual from current National Academies activities and a ban on participation in future activities.

Confidentiality

Information contained in a complaint is kept confidential, and information is revealed only on a need-to-know basis. The National Academies will not retaliate or tolerate retaliation against anyone who makes a good faith report of discrimination, harassment, or bullying.

Responsible Party

The NRC Executive Officer is responsible for oversight of and substantive changes to the policy.
