## Workshop Statement of Task

A planning committee of the National Academies of Sciences, Engineering, and Medicine will organize a <u>public workshop series</u> to explore shortages of clinical/experiential learning environments across health professions. Presentations will be framed around understanding the value of quality clinical/experiential education in the development of health professionals, root causes of site and slot shortages that differ by profession, and impacts the issue has on student learning, employer satisfaction, patient care, and population health. Discussions of innovative solutions to these challenges may draw upon a global audience for participation. The committee will select speakers and facilitators to moderate discussions throughout the series. These discussions could include exploring:

- Current and alternative training and preceptor models;
- Policy and finance considerations;
- Accreditation requirements;
- Clinician wellbeing and minimizing burnout of preceptors;
- Preceptor incentives;
- New academic-practice partnerships; and
- Technology/simulation to support clinical education

Following the series, a proceedings-in-brief of the presentations and discussions will be prepared by a designated rapporteur in accordance with institutional guidelines.

Cheryl Hoying, RN, PhD, NEA-BC, FAONL, FACHE, FAAN has more than 30 years of leadership experience, the majority of those in Vice President/Chief Nurse Executive/Officer level positions in large academic medical centers and community hospitals, including both adult and pediatric settings, ranging from 230-1,500 beds. Her previous roles have included Interim CEO/CNO at the Papas Rehabilitation Hospital for Children, Chief Nurse Executive & Patient Services Officer at The Ohio State University Wexner Medical Center and Senior Vice President for Patient Services at Cincinnati Children's Medical Center. She has also served as, Interim Dean and Associate Dean for the University of Cincinnati College of Nursing, Assistant Dean of Clinical Affairs for the Ohio State College of Nursing, Adjunct faculty at the Wright State University/Miami Valley School of Nursing,

Mount St. Joseph University Department of Nursing, Xavier University College of Nursing and the University of Cincinnati College of Nursing. Dr. Hoying has been professionally active in many health care organizations including a member of the National League for Nursing (NLN), the American Organization for Nursing Leadership (AONL), including president in 2011, The American Academy of Nursing (AAN), the American Nurses Association (ANA), Sigma Theta Tau International Honor Society, and the American College of Healthcare Executives (ACHE).



#### PLANNING COMMITTEE CO-CHAIR

Carl Sheperis, PhD is Vice Provost and Dean of Graduate Studies at Kutztown University, is a recognized expert in the application of artificial intelligence to health professions. He has delivered keynote addresses on AI at conferences across the globe and serves as co-chair for the AI working group for the Global Forum on Innovation in Health Professional Education for NASEM. Dr. Sheperis has published articles on AI in healthcare and is currently editing a new book on the topic. With over 25 years of experience in pediatric and family mental health, Dr. Sheperis has served as an expert to various media outlets, reaching over 50 million readers. He held leadership positions in counseling, including serving as the editor-in-chief for the Journal of Counselor Preparation and Supervision, President of the Association for Assessment and Research in Counseling (AARC), and Associate Editor for the Journal of Counseling and Development. Dr. Sheperis has

authored several textbooks and published entries in various academic journals and reference volumes. He has received numerous awards, including the Outstanding Counselor Educator by the Southern Association of Counselor Education and Supervision, the Counselor Education Advocacy Award and the David K. Brooks Jr. Distinguished Mentor Award from the American Counseling Association (ACA).



Zachary Brian, DMD, MHA, FICD, FACD, FNAP serves as associate professor at the University of North Carolina at Chapel Hill Adams School of Dentistry (UNC ASOD), where in addition to teaching, building curricular innovation strategy, and engaging in health policy research, he directs the school's community-based service-learning program, Dentistry in Service to Community (DISC), and is the founding director of the UNC Program for Oral Health Policy. Dr. Brian's clinical, administrative, and academic career has focused on the intersection of public health and policy in pursuit of health equity for underrepresented and marginalized populations. Before joining UNC ASOD, Dr. Brian served in leadership positions supporting equity-centered initiatives within government, non-profit, and private sectors. He is a member of the Council on Practice for the American

Association of Public Health Dentistry (AAPHD), the Best Practices Committee for the Association of State and Territorial Dental Directors (ASTDD), the Code Maintenance Committee for the American Dental Association (ADA), and the Board of Directors for the National Network for Oral Health Access (NNOHA). Beyond these appointments, he is also a member of the editorial board of the CDC's journal, Preventing Chronic Disease, peer reviewer for the Academy of General Dentistry, and Vice Chairman of the Board for the Chatham County Board of Health. He received his BS from Murray State University, his DMD from the University of Louisville, and his MHA from Central Michigan University. Dr. Brian is a fellow in the International College of Dentistry (ICD), the American College of Dentistry (ACD), and a National Academies of Practice Distinguished Fellow.



Shanita Brown, PhD is a Teaching Assistant Professor in the Counselor Education Program in the Department of Interdisciplinary Professions at East Carolina University. Dr. Brown's research interests including examining the domestic violence experience of Black women and the role of faith and spirituality, trauma-informed practices, and collegiate mental health. She is a Licensed Clinical Mental Health Counselor and Board-Certified National Counselor with over 15 years of experience in the clinical mental health profession. She has served in various capacities, such as school-based mental health, college counseling, and private practice. 





# PREVENTING DISCRIMINATION, HARASSMENT, AND BULLYING: POLICY FOR PARTICIPANTS IN NASEM ACTIVITIES

The National Academies of Sciences, Engineering, and Medicine are committed to the principles of diversity, inclusion, integrity, civility, and respect in all of our activities. We look to you to be a partner in this commitment by helping us to maintain a professional and cordial environment. All forms of discrimination, harassment, and bullying are prohibited in any NASEM activity. This policy applies to all participants in all settings and locations in which NASEM work and activities are conducted, including committee meetings, workshops, conferences, and other work and social functions where employees, volunteers, sponsors, vendors, or guests are present.

**Discrimination** is prejudicial treatment of individuals or groups of people based on their race, ethnicity, color, national origin, sex, sexual orientation, gender identity, age, religion, disability, veteran status, or any other characteristic protected by applicable laws.

**Sexual harassment** is unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature that creates an intimidating, hostile, or offensive environment.

**Other types of harassment** include any verbal or physical conduct directed at individuals or groups of people because of their race, ethnicity, color, national origin, sex, sexual orientation, gender identity, age, religion, disability, veteran status, or any other characteristic protected by applicable laws, that creates an intimidating, hostile, or offensive environment.

**Bullying** is unwelcome, aggressive behavior involving the use of influence, threat, intimidation, or coercion to dominate others in the professional environment.

#### **REPORTING AND RESOLUTION**

Any violation of this policy should be reported. If you experience or witness discrimination, harassment, or bullying, you are encouraged to make your unease or disapproval known to the individual at the time the incident occurs, if you are comfortable doing so. You are also urged to report any incident by:

- Filing a complaint with the Office of Human Resources at 202-334-3400 or hrservicecenter@nas.edu, or
- Reporting the incident to an employee involved in the activity in which the member or volunteer is participating, who will then file a complaint with the Office of Human Resources.

Complaints should be filed as soon as possible after an incident. To ensure prompt and thorough investigation, the complainant should provide as much information as is possible, such as names, dates, locations, and steps taken. The Office of Human Resources will investigate the alleged violation in consultation with the Office of the General Counsel. If an investigation results in finding an individual has committed a violation, NASEM will take the actions necessary to protect those involved in its activities from any future discrimination, harassment, or bullying, including in appropriate circumstances the removal of an individual from current NASEM activities and a ban on participation in future activities.

#### **CONFIDENTIALITY**

Information contained in a complaint is kept confidential, and information is revealed only on a need-to-know basis. NASEM will not retaliate or tolerate retaliation against anyone who makes a good faith report of discrimination, harassment, or bullying.
