#### Quality Assessment and Accreditation System


- Goals Streamlined, Innovative, Aligned, Accessible

## Connecting report to accreditation and position statement content. The TAG provided feedback on:

- The definition of curriculum as stated in Standard 3 of the position statement and accreditation content.
- The role of the teacher in curriculum Standard 3.
- Focus on content and learning goals Standard 3.
- Additional emphasis on how to incorporate curriculum in Standard 4.
- The balance between play and structured learning Standard 4
- Emphasis on intentional teaching practices and strategies- Standard 4
- Educator support and professional development Standard 8

### **Opportunities**

## Challenges

- Competing priorities for early learning programs
- Report less accessible for ECE programs outside of public school districts.
- Tension between play and structured learning.

- Think about your audience and the aspects of the report that are more relevant to them.
- Provide opportunities for reflection and discussion about the report.
- Translate the report into more accessible language and smaller pieces that could resonate more deeply with educators.
