


Trump Broke a Record with Executive Orders

Trump signed more executive orders on Day 1 than any president signed in the first week

Trump signed 26 executive orders on his first day in office, nearly triple the nine orders Biden signed on his first day in 2021. In his previous term, Trump signed only one executive order on his first day (and another four in the first week). Former Presidents Barack Obama and George W. Bush did not sign executive orders on their first day, instead releasing memoranda or proclamations only.

Executive actions signed in the first week of office, by president



The administrative changes included repealing former President Joe Biden's policies, implementing a federal workforce hiring freeze and creating the so-called Department of Government Efficiency. Several other actions focused on immigration and border security, the most prominent of which sought to end birthright citizenship and is already facing legal challenges in court. Other social issues that Trump tackled included ending diversity, equity and inclusion initiatives in the federal government and legally recognizing only two genders.




Most of Biden's orders under social issu included promoting education and protect diversity and equity initiatives, whereas T orders focused on repealing such policies

The Federal Discretionary Budget versus R&D Budget



Select Science & Technology Programs in FY 2025 Appropriations




Nominal percentage change from FY 2024




Historical Perspective of NASA Budget


