COVID-19 magnified health disparities


Baseline care

Large portion of the population lacks access to basic care

Critical need to immediately improve access



Public health partners with pharmacies to accelerate and expand community testing: ICATT










Comprehensive approach: Federal authorities allowed for testing services to be scaled and addressed barriers to access

PREP Act and PHE provided flexibilities to allow for a robust national testing program through pharmacies:

- The PREP act provides **scope for pharmacists** to order all EUA COVID-19 tests and the **scope for technicians** and interns to participate in the testing process that supersede state authorities. (PREP Act, Guidance Document later codified in the 4th Amendment)
- The PREP act grants **licensure reciprocity** for pharmacy personnel to work across state lines. (PREP Act, 5th Amendment)
- The PHE provides **zero cost sharing** for consumers on COVID-19 Tests including OTC tests for Commercial, Medicaid, and Medicare beneficiaries. (PHE)
- The PHE allows **non contracted billing** to payers with zero cost sharing to the consumer. (PHE)

There's an urgent need to accelerate quality care for all

Walgreens is a resource for communities not currently served by the traditional healthcare model, providing safe and convenient access to low acuity healthcare services for patients








COVID-19 testing scaled at Walgreens as national supply to support testing improved



Testing scaled to reach across all communities


Over 35M tests conducted, 50% of all testing sites in

Current Walgreens COVID-19 Testing Footprint across ~7200 locations




Ability to adjust testing based on community needs with over 50% of testing sites in vulnerable areas



Prioritized Sites by store characteristics like Drive thru and area COVID-19 disease rates




Strategically placed testing sites around airports to support testing for travel

Testing locations optimized around schools to meet community needs




