






Issue and Focus




Goal

My goal is to propose the addition of a pedestrian activated signal at the intersection of Columbia Pike and Tyler Street to the Residential Traffic Administration Program of Fairfax County (RTAP) or the Fairfax County Department of Transportation.




Focus Group



Licensed Drivers in Fairfax County


Especially those susceptible to speeding and/or aggressive driving.



Experiences/Background

- Every year, a mother's child is lost, a younger sister loses their eldest brother, or a student, friend, leader, and peer is taken away from their community. The community, and most of all, the families, are left heart-broken, confused, guilty, and angry.
- It's not uncommon for questions such as "Why did this happen?" or "How can this be prevented so that this doesn't happen to another family?" to arise.
- RTAP is a specific program that works directly with communities to decrease the impacts of traffic and enhance safety in area neighborhoods.

Personal Thoughts

On November 16, 2022, a fellow junior at Justice High School lost her life as she was walking to school, crossing the intersection of Columbia Pike and Tyler Street. Although I did not know her well enough to call her a friend, through the classes I'd had with her, I had the gift of experiencing and witnessing her kindness, laughter, and great potential and determination to become a nurse. She had goals, big and small. A little sister, parents who care and worry for her, and an immeasurable life ahead of her, just as I do.

However, there are millions of teenagers out there whose lives and safety are threatened by dangerous driving habits and lack of necessary traffic signs and/or signals. I don't want anybody else to share the same devastating story as the families of teenage pedestrian/driver fatalities. We must not only envision, but build a better and safer future for all.

Roadblock to Building a Safer Future in Fairfax County

The proposed addition of a traffic signal would have to go through an assessment. The VDOT states:

The department follows federal guidelines that establish minimum conditions under which signal installation should be considered.

These guidelines help identify potential locations for signals, but each location is reviewed before a signal is installed.

Traffic engineers determine if a signal is needed by carefully evaluating:

The number of vehicles and pedestrians that use the intersection
The physical makeup of the intersection
Roadside development
Traffic delays during peak hours
Average vehicle speeds
Future road construction plans
The number and types of accidents that have occurred there

Submit application for request of addition of a pedestrian activated traffic signal on the intersection of Columbia Pike and Tyler Street to FCDOT


Pros and Cons

PRO

Pedestrian countdown signals have been shown to have a 25% reduction in pedestrian injury collisions.



Pedestrians will face reduced fear/stress walking and crossing streets, and this may possibly encourage more exercise.



CON

Installing pedestrian signal phasing when the crossings are currently unsignalized can range from \$65,000 to \$250,000.

Partnerships

State organizations I can work with to progress my proposal and make change a reality are the FCDOT and VDOT. A nation-wide advocacy group for building safer streets and public spaces that allow people to safely walk and move is another group I can contact to gain support and a voice in my campaign.
