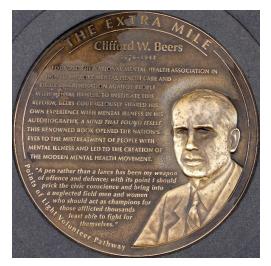

MHA Screening reflects the experiences of a help-seeking population that accesses mental health screening through <a href="www.mhascreening.org">www.mhascreening.org</a>.

We do not reach the entire population; therefore our numbers are likely to underreport the actual experiences of the population.



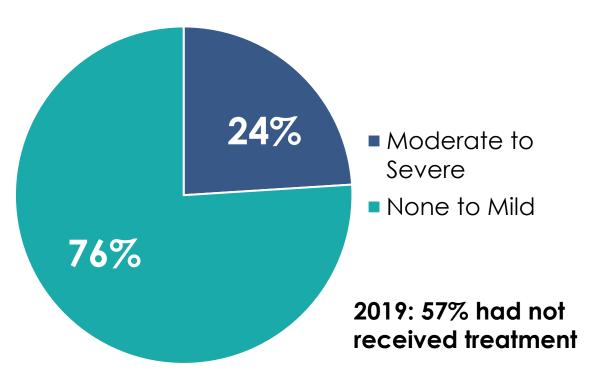
### Overview of MHA Screening Demographics

- Data are deidentified, demographic data is voluntary, up to 80% of users answer at least one question.
- Over 13 million screeners since 2014;
  - Represent a help-seeking population for mental health conditions;
- 70% are female;
- Screeners screen more often for depression than any other condition;
- 45% are youth under 18;
- 49% identify as a racial/ethnic minority;
- In 2020, MHA results are consistent with the US Census Bureau Pulse Survey and CDC findings.

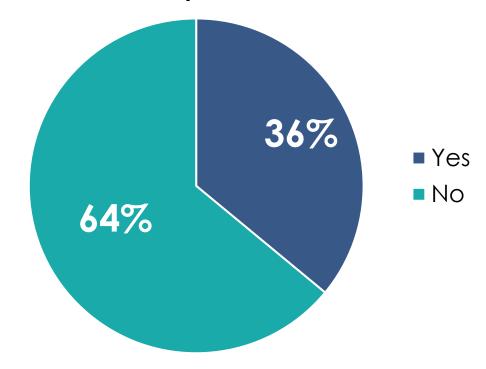


# High Severity, No Previous Support

Percent Scoring Moderate Severe for all Conditions



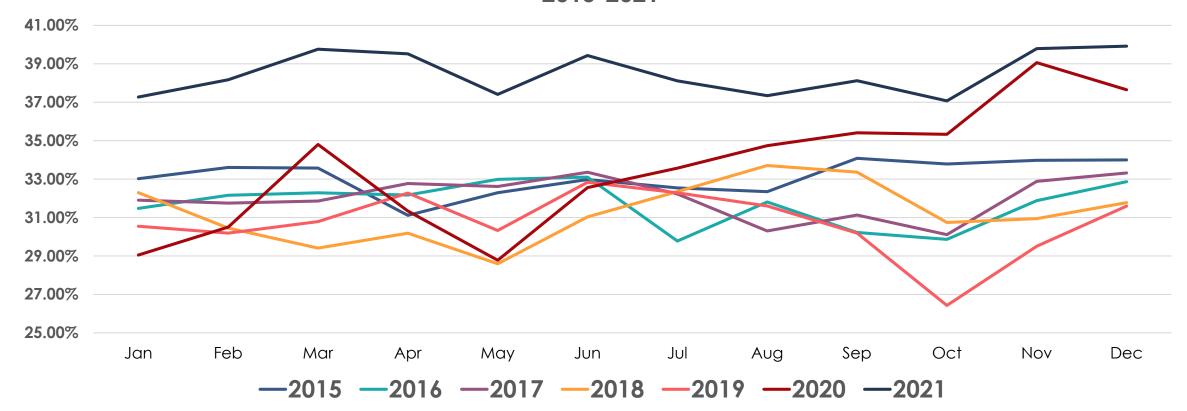
Have you ever received treatment or support for a mental health problem?





# Suicidal Ideation Reported at Higher Rates Since June 2020

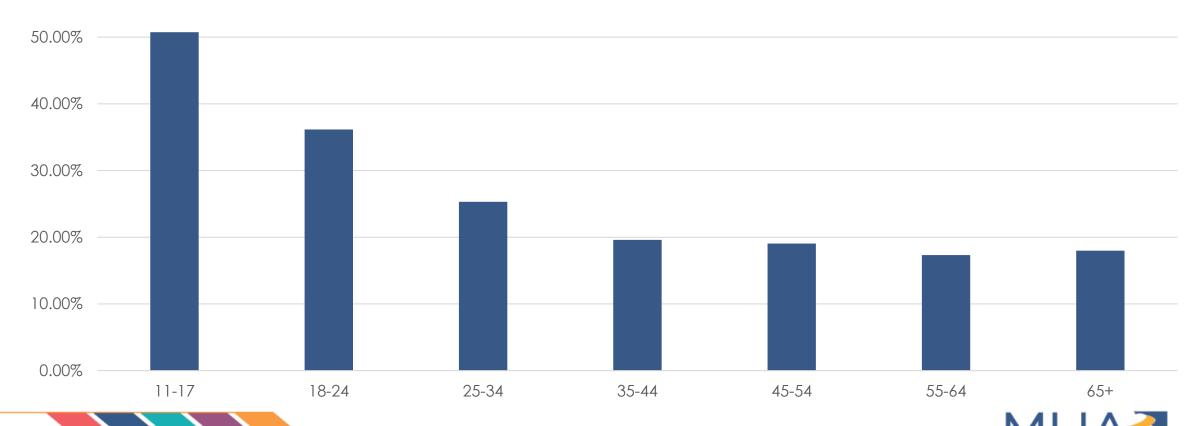
Percentage Reporting Suicidal Ideation More Than Half or Nearly Every Day 2015-2021





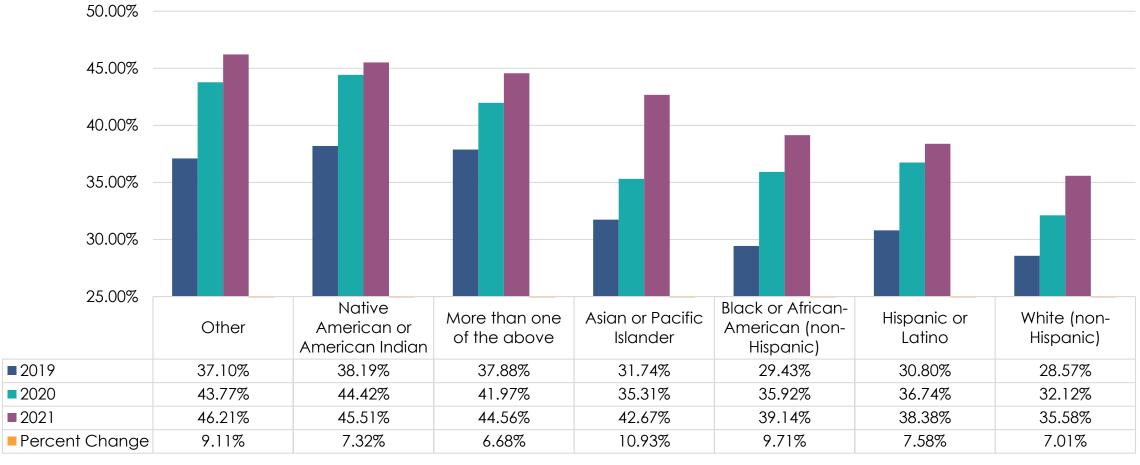
# Suicidal Ideation Highest Among Youth

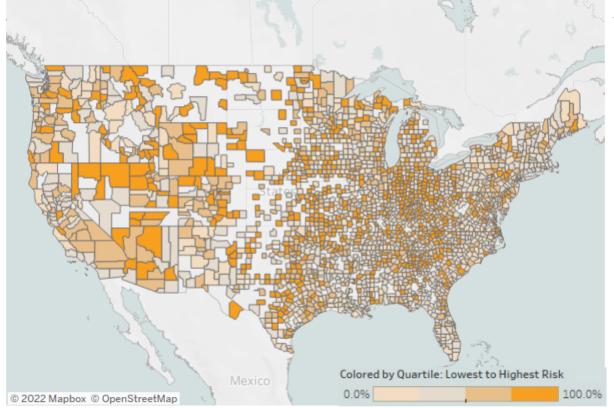

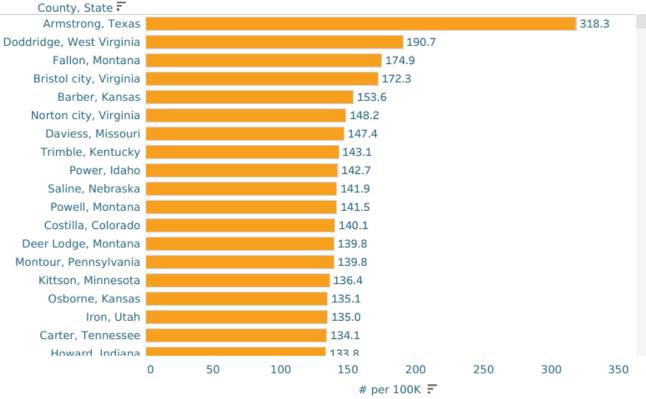
**Suicidal Ideation Map County** 

Hover over the states to see the county breakdown for suicide risk within that state. States and counties are colored by quartiles. Darker colors indicate greater risk.

### Breakdown by County

By default, states are listed in ascending order (from states with the lowest number of individuals per 100K reporting frequent suicidal ideation to highest) and counties are listed in descending order. Click on the axis to change the sort order. When selecting a State on the map, the corresponding position on the chart will be highlighted.





# Mental Health America's Focus

- Prevention and early identification:
  - Population health
  - Creation of free co-designed digital tools (patient and community participatory research)
- Policy: Use of data to inform policy and programming at federal and local level
  - US Preventive Services Task Force suicide screening: complexity of suicidal ideation, thoughts of death, NSSI and equity issues.
  - Funding and implementation of 988 and other crisis related interventions
  - Build infrastructure for person and recovery-oriented crisis supports, including mobile crisis, peers, peer run respite.



## **Current Research**

- Northwestern University and the University of Toronto.
  - The project investigates the feasibility and impact of text-based interventions post screening.
  - The project seeks to understand NSSI among young adults and test the feasibility of digital mental health intervention
- **Dartmouth and Microsoft** titled: Examining Mental Health Using Online Search Data and Online Screening. The study is using data collected from MHA and Microsoft Bing to evaluate the search behaviors of people who search on Bing and take a mental health screen with MHA to understand concerns before and after taking a mental health screen and greater understand the timeline for optimal engagement and intervention in online setting.
- University of California, Irvine titled: A Crowd-Powered Technological Treatment for Depression and Anxiety. The
  project investigates using crowd resourced information to build improved digital application tools using cognitive
  behavioral therapy.
- University of Washington and Talkspace title: Enhancing Engagement with Digital Mental Health Care. The project seeks to understand the characteristics of optimal engagement with digital mental health treatment, and to identify effective, personalized methods to enhance motivation to engage in digital mental health treatment in order to improve mental health outcomes.

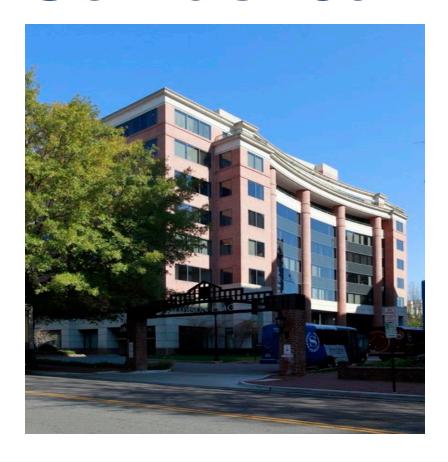
