





#### **Conditions for Which Consultation is Sought**












# Telemedicine Visits by Mental Health Provider Type




YEAR 3: Telemedicine for Med Management = 69, Telemedicine for Therapy = 128



#### Caregiver Semi-Structured Interviews

#### **Overview**

May 2021 – June 2021

GOAL: Understand the caregiver experience related to the services provided by the PATHS programs.

#### **Interviewees**

- 8 Interviews
- 8 rural counties represented
- Interviews represented various types of caregivers including mother, father, and grandmother



## **Telemedicine**

# **Caregiver Perception of Needing Service**

- Inconvenient
- Initially skeptical
- Trust pediatrician guidance
- Trust in Standard of Care

#### **Child Improvement**

- Comfort and trust with PATHS providers
- Improved symptoms
- Improved communications



## Plan of Care and Scheduling Process

#### **Plan of Care**

- Frequent communication and discussion with providers
- Pediatrician follow-up

#### **Scheduling Process**

- Organized and efficient
- Responsive and supportive team



## **Strength and Areas of Need**

#### Strengths

- Easy to access, convenient, and flexible
- Good communication and connection
- High quality care across Alabama

#### **Areas of Need**

- Internet access and improvements
- Community recruitment and education



#### CAREGIVER FEEDBACK

"As far as improved, she's not as anxious as she was. She was having a lot of crying episodes and was very depressed. She was suicidal and homicidal and now she is totally different...At one point she wanted to give up, and now she's talking college. She's engaging in extracurriculars."

It's opened up the opportunity for families to take advantage of things that were not available to them.

At first, I was skeptical about it because I feel like you can read a person better through the face-to-face visit vs. talking to someone through a screen, but I was willing to try it to see how it worked out. I have not been disappointed. It wasn't as impersonal as I thought it would be. They have really connected with their psychiatrist.

I didn't know what to do or know which way to go but after being introduced to the PATHS program, it's been a complete turnaround in our household with my daughter. For the first time in a long time, I feel she has an opportunity for a great future.



#### PROVIDER FEEDBACK

"Just this morning we had a crisis with a patient, and my whole team knew just what to do because we'd participated in ECHO. We handled it fine!"

"I just wanted to call and tell you how much I appreciate PATHS and how valuable the support is. The telemedicine piece is working great! I appreciate the psychiatrist's call to follow-up with me regarding my patient – that never happens normally."

"Please pass on to the team that the two huge challenges they took on from my clinic were Grand Slams! The little six year old with a diagnosis of Autism was really a child sexual abuse case. The child is off all meds. She is able to talk openly with family about her painful memories. She is a model student with great success in the classroom thus far. The other patient has made such great strides. I greatly appreciate the efforts to make this work. This program is changing lives in rural Alabama."
