# **UC Efforts Related to Research Security**

The University of California has taken an enterprise approach to addressing research security issues.

- Our compliance program is built on a risk-based framework for systematic identification of issues and a design of mitigation strategies.
- UC has leveraged existing policies and procedures in creating an integrated approach, leveraging the independent Office of Ethics, Compliance, and Audit Services (ECAS).
- UC's approach has focused heavily on a systemwide training and awareness program, targeted research and cyber audits, as well as enhanced investigative protocols and practices.
- ECAS cultivated strategic collaborations with both internal and external stakeholders.

Mandatory briefing for UC researchers taken every two years.

## **Research Security Audits**

# **Foreign Influence Audit**

ECAS performed a systemwide audit to evaluate risks related to foreign influence that included the following areas:

- Conflict of Interest
- Conflict of Commitment
- Export Control
- Sponsored programs/grant processing
- Development and alumni relations
- Visas for international scholars and student/graduate studies
- International activities
- Academic departments and faculty
- Intellectual property security and control
- Training

## **Research Security Audits**

#### **Cybersecurity Audits**

ECAS' Cybersecurity Audit Team performed a series of audits to assess systems and controls in place to protect research data and other highly sensitive information throughout the system, including:

- Systemwide Vulnerability Assessment and Penetration Testing Audits Research and Emerging Technology
- Systemwide Threat Detection and Identification Audit
- Systemwide Critical Infrastructure Audits
- Systemwide Cyber-Resiliency Audit

# **Investigations**

#### **UC standardized Foreign Influence investigations**

ECAS created escalation protocols requiring all foreign influence allegations to be immediately elevated to the highest levels of the institution, ensuring that ECAS and the Office of General Counsel have visibility.

Multi-disciplinary team reviews of allegations ensuring the thoroughness of investigations.

Designed detailed investigative plans for foreign influence investigations that outlined procedures for:

- Preserving and collecting physical and digital evidence
- Identifying relevant internal and external documents related to the allegations
- Conducting targeted, multi-lingual, media searches for publicly available information
- Created quality control procedures to ensure thorough and consistent investigations systemwide and appropriate disclosures to federal agencies

# New Research Security Framework for International Affiliations

International Affiliations and Agreements involving "Countries of Concern" and "Emerging Technology"

## **Proposed Affiliations and Agreements**

Prospective international affiliations and agreements involving both "Emerging Technology" and "Countries of Concern" must undergo an enhanced review and approval process.

## **Current Affiliations and Agreements**

Develop a detailed inventory of all current international affiliations and agreements involving "Countries of Concern" to identify high risk engagements requiring further review or analysis.
