# HISTORY OF Navajo Nation Human Research Review Board

- 1979 Navajo Area Indian Health Service (NAIHS) Institutional Review Board (IRB) established;
- 1992-1993 Navajo Area Indian Health Service (NAIHS)/Navajo Nation Institutional Review Board established and operated;
- 10/1995: Navajo Nation Council enacted the Navajo Health Code (CO-106-95);
- 01/1996: Navajo Nation Health Research Review Board (NNHRRB) started reviewing proposals.

## **Enabling Legislative**

The Navajo Nation Human Research Review Board was developed in1996 to guarantee ethical research for the Dine' People.

<u>Purpose</u>: The purpose of this Code shall be to set forth the conditions under which investigators, physicians, researcher and other may perform heath and health related research activities within the territorial jurisdiction of the Navajo Nation;

<u>Policy</u>: It is the policy for the Navajo Nation to ensure that all persons within the territorial jurisdiction of the Navajo Nation are free from unreasonably harmful, intrusive ill-conceived or otherwise offensive research and investigation procedures.

#### **GUIDELINES**

- 1. The proposal must include **all** of the **necessary documents listed below in the order as listed in the Table of Contents before** it will be accepted for review:
  - 1a. Cover sheet of the IRB Research Protocol Application (NNHRRB-01)
  - 1b. Abstract
  - 1c. Part 1: Community Involvement
  - 1d. Part 2: Benefits to the Navajo Nation
  - 1e. Part 3: Research Project Description
  - 1f. Part 4: Informed Consent Form
  - 1g. Part 5: Certification by the Principal Investigator
  - 1h. Part 6: Attachments
    - Curriculum Vitae of Principal Investigator and Co-Principal Investigators.
    - Approving Resolutions from Agency Councils of the Navajo Nation.
    - Support Letters from CEO's of NAIHS Service Units and Navajo Nation Program Directors.
    - Copies of other approved IRB Letter(s).
    - Certificate of Confidentiality (if necessary).
    - OMB Clearance Document (if necessary).
    - A copy of the written letter to the Navajo Nation Historical Preservation Office (if applicable), and
    - Budget
- Twelve (12) copies of the research proposal/evaluation must be submitted to the Navajo IRB Office <u>two months prior to the anticipated date of</u> <u>presentation</u>. The post office address and express package delivery address is:

3. All research proposals/evaluation must be submitted in pre-punched 3-hole 8 <sup>1</sup>/<sub>2</sub> x 11 white bonded paper clipped by large binder clips. Each proposal must follow a table of contents as outlined on this page. <u>Each page shall be numbered.</u>

Some examples of approved studies on Navajo Nation:

- Diabetes (Type II, Prevention Programs, Obesity, Nutrition, Education, Youth Diabetes);
- Diseases (Respiratory, Cardiovascular Risk, Pneumococca, Celiac)
- Uranium (cancer, water, plants, animals, radon, Mining, Mine workers, unregulated drinking water, Health Impact );
- Cancer (Mining, Breast, Colorectal, Lungs, preventions, screenings, awareness, intervention);
- Navajo Language, Cultural (Understand Navajo Language, Cultural, People, Barriers & Support of Navajo Principals, Cultural Beliefs & Ritual Influence;
- Curriculum (Navajo full immersion, Indian Head Start Literacy, Listening to each other development, National Indian Education Study, Navajo Teacher Training Program, Impact of No Child Left Behind Act on NM and AZ Public Schools on Reservation, Indian Education in NM);
- Nutrition (Farming, Diabetes, Food for life, Cooking to Live, Edible School, Garden Program, Health & Horticulture Wellness, WIC, Food Distribution on Indian Reservation, Farm to Table Study);
- Environmental Health (Well Water, Investigation of Well Water, Environmental Health Project, Variable and changes);
- Efficacy (Efficacy Trial among Apache and Navajo Indian Infant of Haemonphilus Influenza Type B, Efficacy of Pneumococcal Conjugate Vaccine, Nasopharyngeal Carriage of Streptococcus pneumonia, Safety and Efficacy of Pentavalent (G1,G2, G3,G4,and P1) Human-Bovine Reasserting Rotavirus Vaccine, Double Blind, Controlled study of the Efficacy Immunogenicity, Safety, and Tolerability and Effectiveness of a Pneumococcal Conjugate Vaccine)
