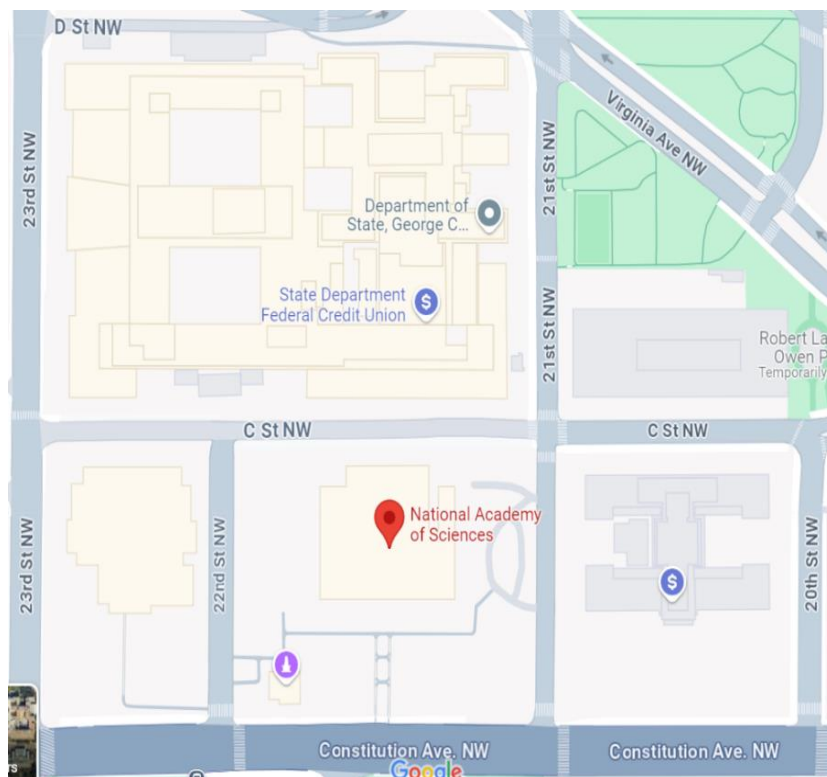
November 18-19, 2024 | National Academy of Sciences Building

MEETING LOCATION

This event will be held in **Room 120** at the National Academy of Sciences Building*, located at **2101 Constitution Avenue NW, Washington, DC 20418**.

A government-issued ID will be required to enter the building.

Driving/Parking: There is a small visitor lot off of 21st Street NW that can only be accessed via Virginia Ave. NW – the Constitution Ave. intersection is closed for northbound travel. Use the following address in GPS: **256 21st St NW, Washington, DC, 20418**.



By Metro: Take the Orange or Blue Line to Foggy Bottom-GWU Metro stop. Turn right when you exit the station. Head south down 23rd Street, NW for approximately 7 blocks. Turn left onto C Street, NW (after the State Department). Cross 22nd Street. The main entrance is in the front of the building (2101 Constitution Ave.). A secondary entrance is located at 2100 C Street.

**Note that there are two buildings associated with the National Academies in Washington D.C. Please make sure you go to the NAS Building on Constitution Avenue (near the State Department) rather than the Keck Center located in Judiciary Square.*

MEALS

Breakfast, lunch, and beverages will be provided on both days of the event. Light snacks will be provided at the networking hour on Day 1. Meal options will be available to fit a variety of dietary requirements, including options that are vegan, vegetarian, gluten-free, nut-free, and which meet other requests submitted by November 4.

ACCESSIBILITY *(please refer to map on the final page)*

- The NAS Building has multiple entrances. The ramped entrance on **C St. NW is the most easily accessible** for people who want or need to avoid stairs. If arriving by car service, request to be dropped off on the corner of C & 21st Streets, as access to the entrance itself is restricted by a State Department barricade.
- A second entrance to the building is located on Constitution Avenue. To avoid steps, please use the door to the right of the main entrance. This side entrance provides access to an ADA-compliant elevator that will take you to the main floor of the building.
- A gender-neutral and accessible bathroom can be found near the C St. entrance.
- A small number of stairs separates the meeting room and the meal area (NAS West Court). An elevator is available to transport people between these two spaces as needed (see map).
- In addition to having CART (Communication Access Realtime Translation) captioning online, a screen in the meeting room will run a live, human-generated transcription of the meeting discussion.
- NAS Room 123 has been reserved as a dedicated quiet space. Please feel free to sit in this room if you need a break. Please note that this room is meant for quiet activities—please do not use for conversations, meetings, or phone calls.
