

## **Skilled Home Health Care – Expanded Overview**

- Expanded Care, also called private duty nursing, may be utilized by VA Medical Centers when veteran care needs exceed skilled home health care bundled SEOC levels. This benefit is used to maintain veterans with complex conditions in their home.

## **Veteran Patient Examples**

### How we help

Maxim provides a full scope of nursing, caregiving and CNA-level care for veterans. Our services include assistance with medically necessary one-on-one services such as pain management, feeding tube care and ventilator management, among other treatments. We can provide this care at home and in acute care facilities through the Veterans Affairs (VA) benefit programs for those who qualify. Here are several real-life examples of these benefits being used across the country:

#### Veteran A

#### Primary diagnosis: ALS, G-tube and Cough Assist Machine dependent

#### Veteran location: West

#### Hours and level of care:

8 hours per day x 5 days per week of Private Duty Nursing approved through the Expanded SEOC

#### Veteran B

Primary diagnosis: Throat/tongue cancer, trach

#### Veteran location: East

Hours and level of care:

10 hours per day x 7 days per week of Private Duty Nursing approved through the Expanded SEOC

#### Veteran C

Primary diagnosis: Quadriplegic, C1-C4 incomplete (Motor Vehicle Accident, nonservice connected)

#### Veteran location: Midwest

Miuwesi

#### Hours and level of care:

28 hours of Private Duty Nursing through Expanded SEOC and 28 hours of homemaker services through Homemaker & Home Health Aide SEOC

### Veteran D

Primary diagnosis: Multiple sclerosis

#### Veteran location: Southeast

Hours and level of care:

12 hours weekly, 2 hours per visit for up to 6 visits per week approved through the Bowel & Bladder SEOC



# **Evolution of VA funded Veterans**

- Before CCN was established in 2019 access to expanded care was very much VAMC specific
- 2019 CCN established the expanded care SEOC and access has been easier ever since
- Access continues to grow see FOIA data below
  - 51% of VAMCs used expanded care in December 2022 compared to 31% in January 2022
  - 116 expanded referrals/month in Q1/Q2 and 171 month in Q4
- Barriers to access:
  - Not every VAMC has yet to adopt this level of care
  - 65% Rule
    - <u>VA Fee Schedule</u>

Veterans access to care is still dependent on where they live not on their needs



# **Recommendations for the Committee**

- Have legislators track the utilization of expanded care per VAMC
- Changing the 65% rule to 100% or more of facility cost Elizabeth Dole Act is already in the works
- Ensure the VA continues making progress to balance the amount spent on home and community based care
