
- Largest coordinated emergency incident in Wisconsin state history
- 920 firefighters from 106 fire departments
- 25 agencies
- Overall IC - Asst Chief Michael Quint



Tire Fire Satellite Imagery

- Smoke plume - 637 sq miles including 290 sq miles over Lake Michigan
- 6 days
- F-500 firefighting foam
- Former US EPA Superfund

Code PFAS

- Researched firefighting foams containing PFAS
- Information shared with:
 - Watertown Fire Department
 - 106 fire departments at the Watertown tire fire
 - 762 Wisconsin & 776 Missouri fire departments
 - (IAFC) International Assn of Fire Chiefs, (IAFF) International Assn of Fire Fighters, state fire chiefs' associations & state fire marshals


1.2M firefighters -- 70% are volunteers

Fire Service on PFAS

- Fire service has been unaware of PFAS toxicity in Aqueous Film Forming Foam – AFFF
- Incident Commanders (ICs) are considered the first line risk managers
- Tested replacement fluorine-free foams are available
- Now, citizens are educating the fire service when they find out their water sources are contaminated with AFFF

Change is coming!

- Foam Exposure Committee was formed because of concern about firefighters' exposures to PFAS in firefighting foams
- Alert issued for fire extinguishers by the National Assn of Fire Equipment Distributors (NAFED)
- Insurance & legal pressures building
- Multi District Litigation (MDL)



Why now?

- AFFF is in water sources worldwide
- Airports & military are still using AFFF
- States are now collecting older AFFFs
- 360,000+ fire apparatus in 58,000 fire stations
- Fire departments are charged with protecting the public

Firefighter Exposures

- Higher cancer rates than the general population
- Ingestion and / or inhalation during foam application
- Eat & drink while on incident sites
- Contaminated drinking water & food
- Dermal absorption

Rock River water samples tested

Test results handed off to the Wisconsin Department of Natural Resources

Marinette - Tyco Fire Technology Center – decades of firefighting foam use continues to flow into Lake Michigan

City municipal water sources in Marinette and the Town of Peshtigo are contaminated Great Lakes provide water for 30M citizens

Madison - Lake Monona was contaminated during downtown transformer fires by the Madison Fire Department with a FireAde product - public pressure increased until they changed over to real fluorine-free foams that were tested






Delivery systems of AFFF in Containers by Volume

“70 ppt is equivalent to about three-and-a-half drops of water in an Olympic-sized swimming pool” - - David Andrews, Senior Scientist at EWG said the fact PFAS are even measured in parts-per-trillion is a signal of the risk potential.²

PFAS Blood Testing

- Military firefighters can now receive PFAS blood testing
- Retired military firefighters – can not
- What do the high PFAS #s in their blood mean?
- How will they lower PFAS in their blood?
- Blood testing / medical monitoring would help firefighters protect their health & get them access to care, when needed
- Dr. Jeff Burgess, University of Arizona, is working on firefighter exposure studies

What can be done right now?

All US firefighters need PFAS blood testing

Retired military firefighters need PFAS blood testing

Fire departments can stop using AFFF right now – there are no regulations requiring them to use AFFF
