21st Century Cures Act

- December 2016 in the 21st Century Cures Act

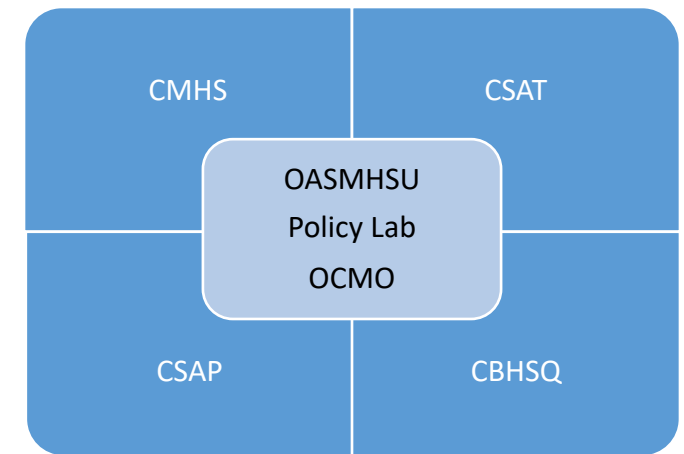


- The Cures Act created the Assistant Secretary position, as well as the National Policy Laboratory and the Office of the Chief Medical Officer
- Central Function of the National Policy Laboratory and the Office of the Chief Medical Officer:
 - Assist the Assistant Secretary and SAMSHA leadership in a refocus of SAMHSA priorities and processes and to have a coordination role across Centers/office at SAMHSA.

Organization of SAMHSA

General SAMHSA Organization:

- **OASMHSU:** Offices of the Assistant Secretary for Mental Health and Substance, the National Policy Lab and the Office of the Chief Medical Officer
- **CMHS:** Center for Mental Health Services
- **CSAT:** Center for Substance Abuse Treatment
- **CSAP:** Center for Substance Abuse Prevention
- **CBHSQ:** Center for Behavioral Health Statistics & Quality



21st Century Cures Act

- Creation of the Policy Lab and Office of the Chief Medical Office to liaison between the Administration (SAMHSA) and providers of mental and substance use disorder prevention, treatment, and recovery services
- Develop the evaluation, organization, integration, and coordination of programs operated by SAMHSA
- Participate in regular strategic planning with the Administration (SAMHSA)

21st Century Cures Act

- Provide leadership in identifying and coordinating policies and programs, including evidence-based programs, related to mental and substance use disorders
- Coordinate and facilitate the implementation of policy changes likely to have a significant effect on mental health, mental illness, recovery supports, and the prevention and treatment of substance use disorder services

SAMHSA shall consult with:

- NIH on an ongoing basis
- Clinical and analytical experts with expertise in psychiatric medical care and clinical psychological care, corrections health care and mental health court systems, as appropriate
- Other individuals and agencies as determined appropriate by the Assistant Secretary

In order to achieve its mission, SAMHSA has identified five priority areas to better meet the behavioral health care needs of individuals, communities, and service providers. The five priority areas are:

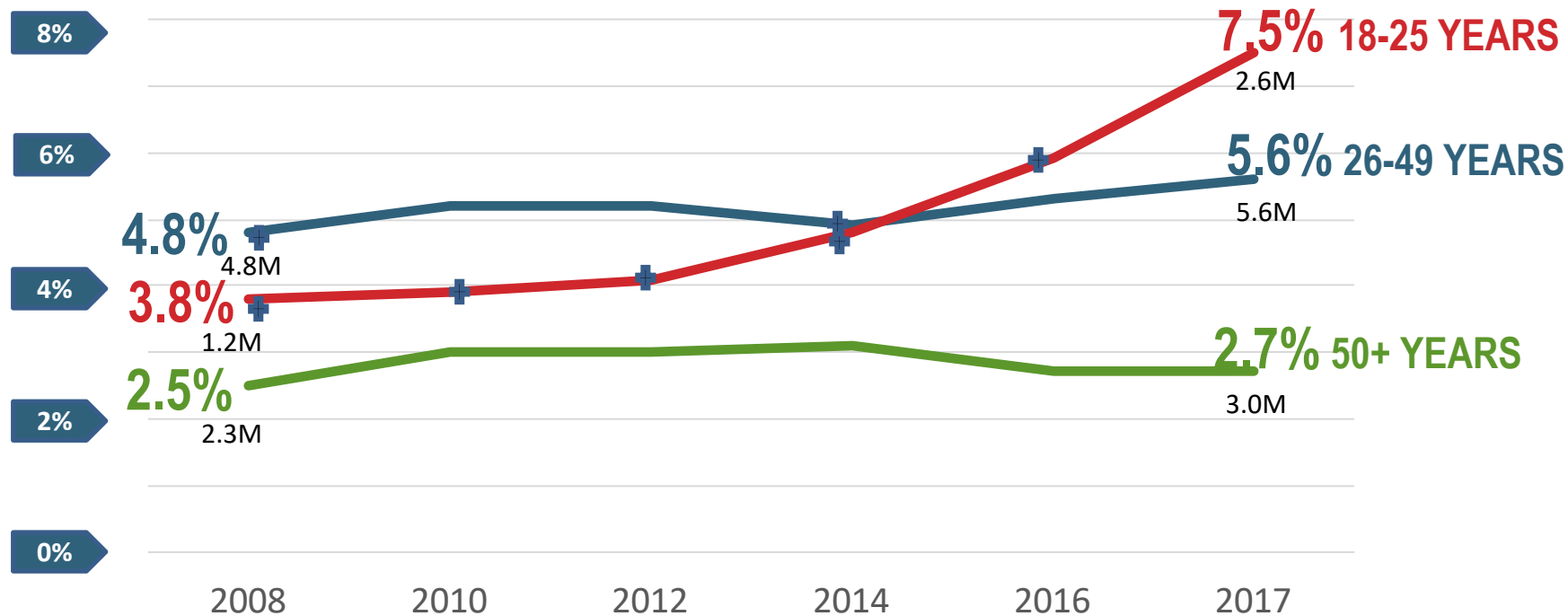
1. Combating the Opioid Crisis through the Expansion of Prevention, Treatment, and Recovery Support Services.
2. Addressing Serious Mental Illness and Serious Emotional Disturbances.
3. Advancing Prevention, Treatment, and Recovery Support Services for Substance Use.
4. Improving Data Collection, Analysis, Dissemination, and Program and Policy Evaluation.

PAST YEAR, 2017, 18+



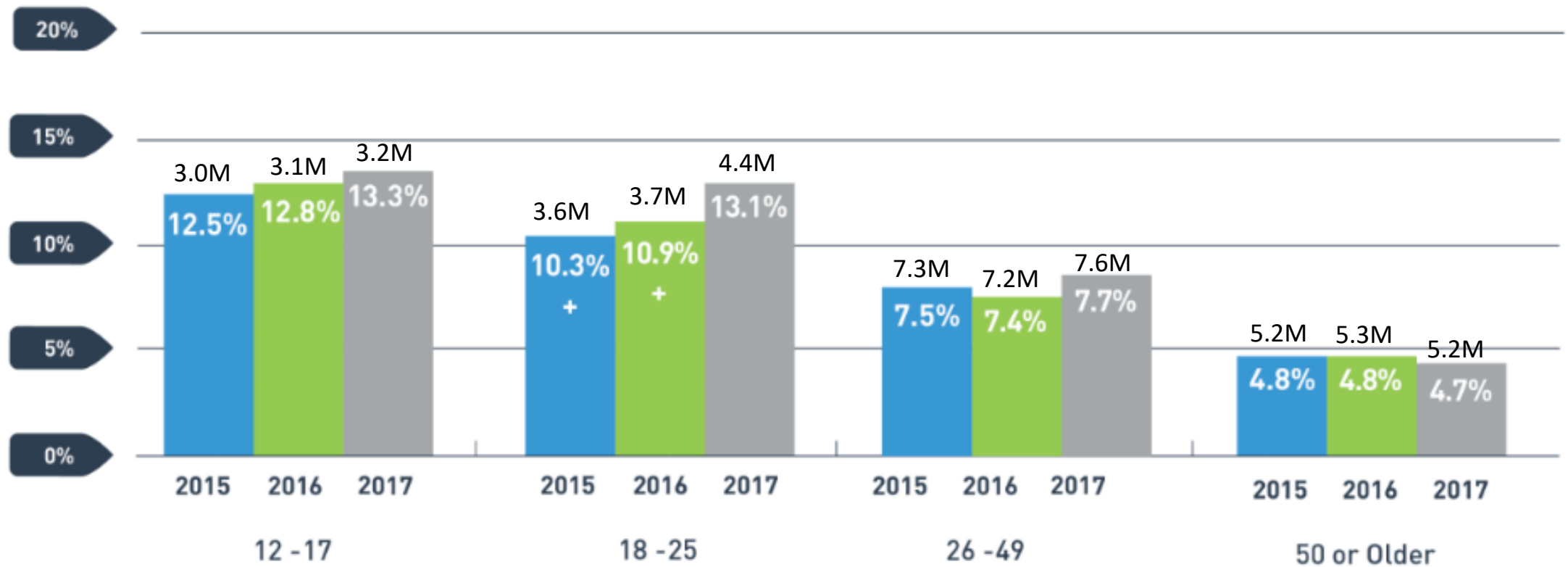
57.4%

PAST YEAR, 2017, 12+



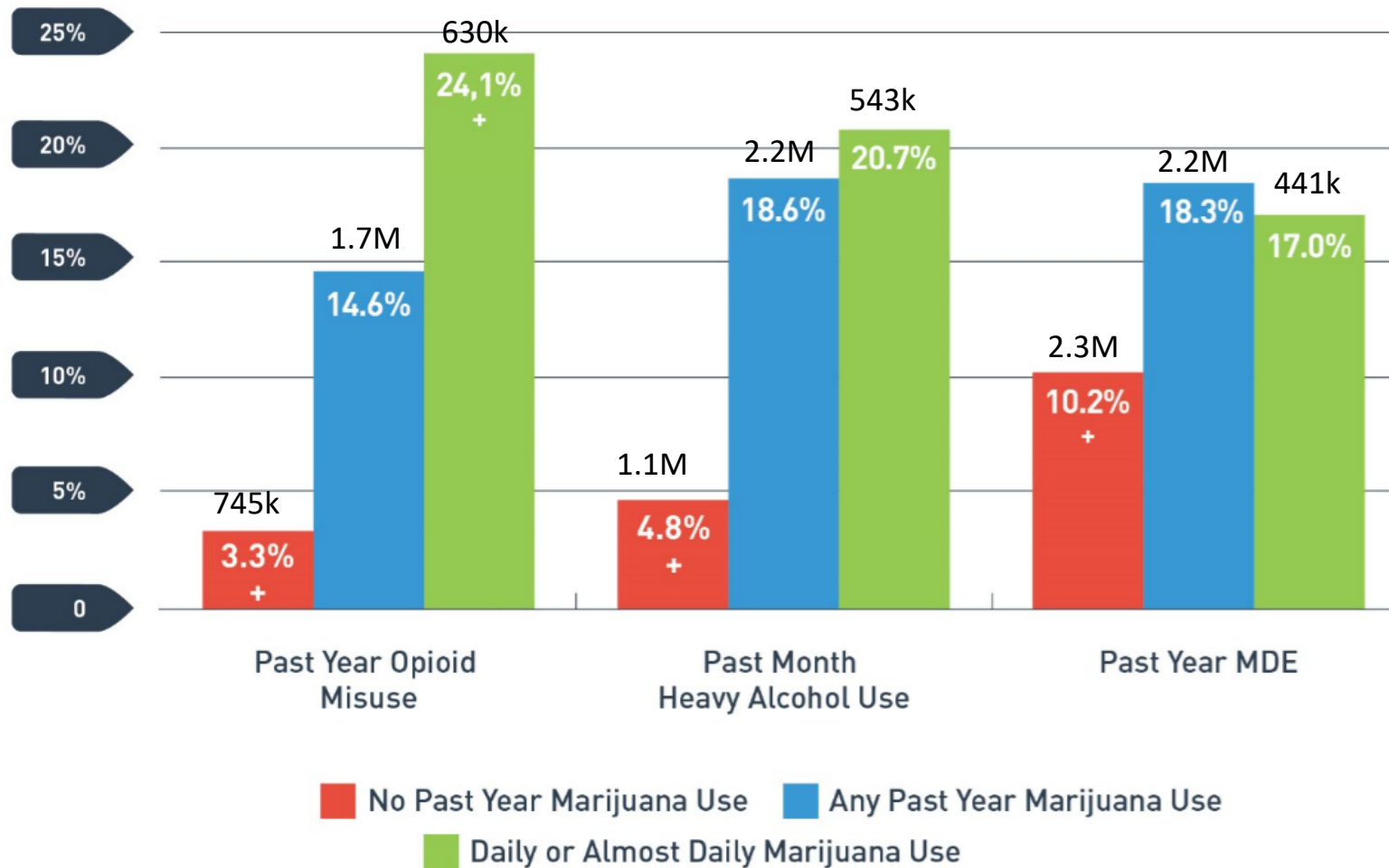

PAST YEAR, 2017, 18 - 25

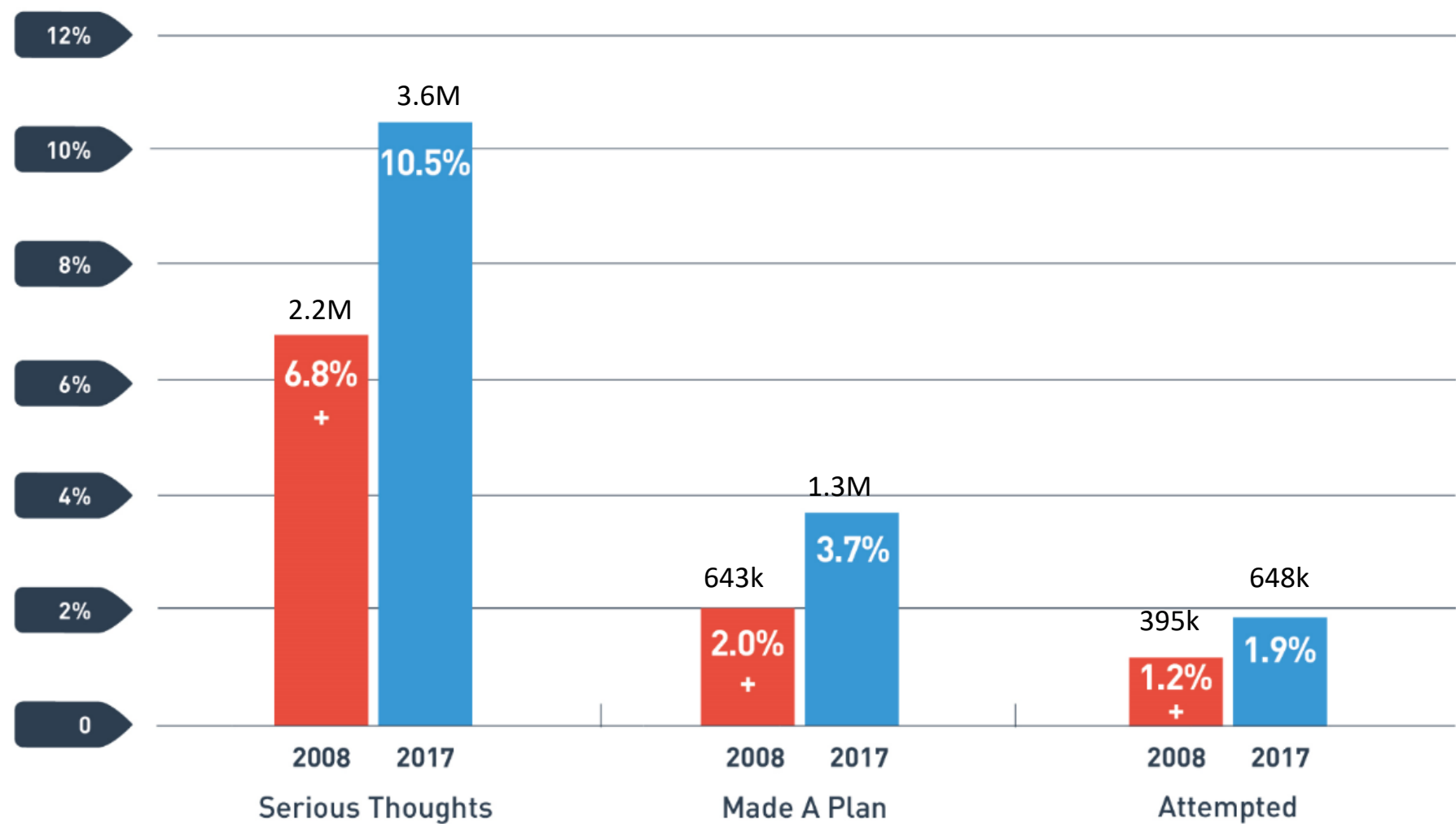

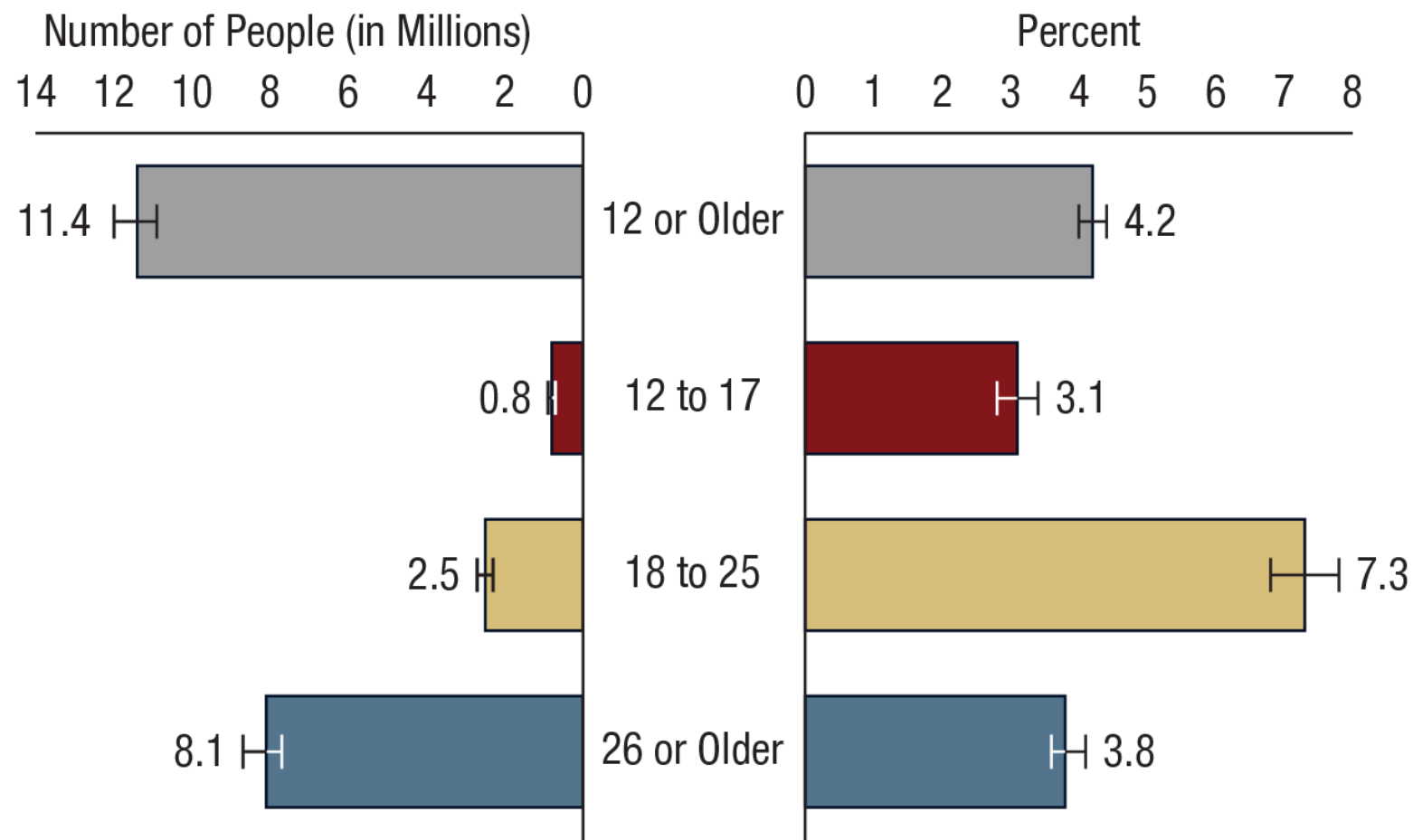
Suicidal Thoughts, Plans, and Attempts Increase for Young Adults

Mental Health and Substance Use Concerns in Higher Education

- In cases of clinically diagnosable depression, 60.8% of students reported feeling overwhelming anxiety; 38.2% reported feeling so depressed it was difficult to function(American College Health Association, 2016)
- Mental illness can have detrimental effects on students' academic progress, as 62% of undergraduate students who dropped out identified they did so due to a mental health issue (NAMI, 2014)
- Data show that college students have consistently higher rates of heavy alcohol use than their non-college peers (NIDA, 2016)

Consensus Study: Supporting the Whole Student: Mental Health, Substance Use and Well-Being in Higher Education

Study purpose is to examine:

- The prevalence and etiology of reported mental health concerns among all undergraduate and graduate students (at all types of 2-year campuses, 4-year campuses, and R1 universities)
- The research on the policies, programs, models, and practices that institutions have implemented to address mental health, substance misuse, and well-being of students

Consensus Study: Supporting the Whole Student: Mental Health, Substance Use and Well-Being in Higher Education

Research Questions:

- What is known about evidence-based approaches to improving mental health and well-being for students?
- How can institutions ensure adequate support for all students, including historically underrepresented groups?
- How can institutions best serve the nation's veterans?
- How can institutions create a comprehensive strategy that acknowledges the ways different cultures recognize mental health and well-being?

Scope of Work

Landscape Analysis:

- Drawing on available literature and survey data, the committee will examine research on and trends in mental health and substance use service needs and over the last decade
- Review programs, practices, resources, and policies that institutions of higher education have developed to treat mental health and substance use issues among students and to support student well-being on campuses

Scope of Work

The committee will organize a series of stakeholder meetings and listening sessions with:

- Undergraduate and graduate students, faculty who mentor students, deans and department chairs at various types of institutions
- Campus mental health administrators at 2-year, 4-year, and R1 institutions of higher education
- Scholars and researchers that have conducted extensive research on this topic
- Education policymakers at the state and local levels

Scope of Work

Develop a set of recommendations that would be aimed at multiple audiences, including:

- Mental health professionals on campuses
- University administrators (presidents, provosts, deans, department chairs and faculty; student associations; professional societies)
- Federal agencies such as HHS and the U.S. Department of Education
- Congress, and state legislatures

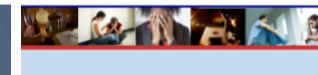
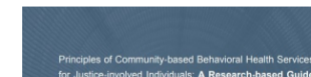
SAMHSA is committed to improving prevention, treatment, and recovery support services for mental and substance use disorders.

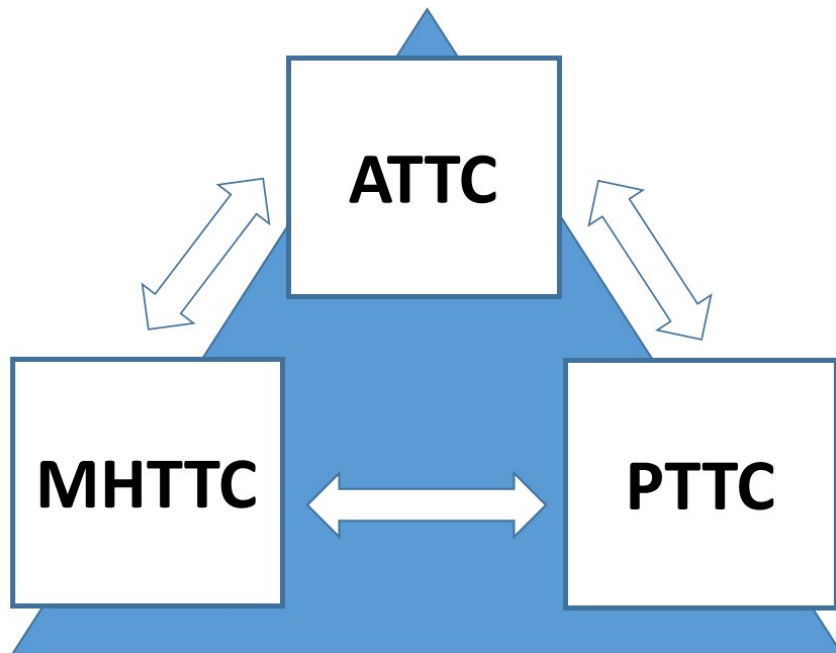
Evidence-based Practice Resource Center (EBRC)

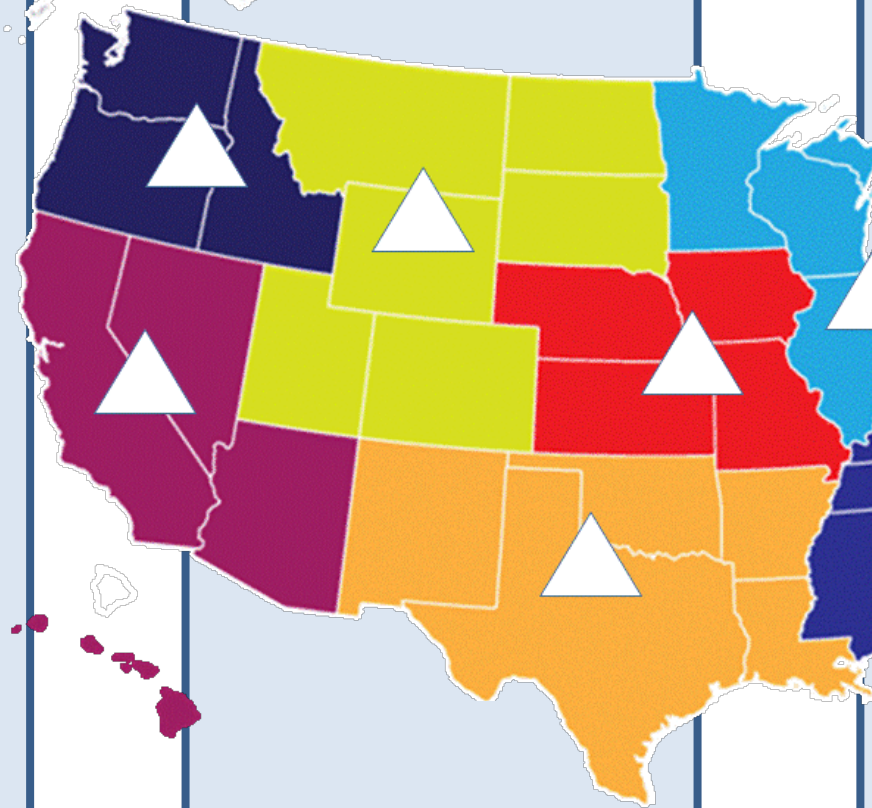

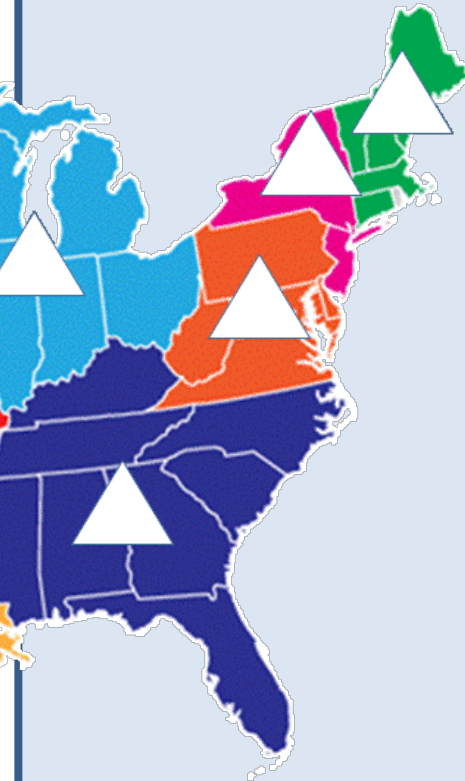
