Alena Berube, MS | Alena Berube is the Director of Policy for the Green Mountain Care Board, Vermont's independent regulatory body overseeing health system regulation and performance transparency. She is also a PhD student at The Dartmouth Institute for Health Policy and Clinical Practice, where her research focuses on the drivers and impacts of high-performing health systems. Alena brings extensive experience in large-scale policy development and the implementation of new programs. Before entering the field of health policy, she worked in other public domains including education finance and tax policy, building a strong foundation in public finance and evidence-based policymaking. She also has a background in organizational science research and previously worked in the private sector in corporate finance and business process improvement, with a focus on enhancing efficiency and strategic decision-making within complex organizations. She holds a Master of Science in Strategic Management and Entrepreneurship from the University of Maryland, College Park, and a Bachelor's degree in Finance from Virginia Tech.

Christopher F. Koller, MA | Christopher Koller is president of the Milbank Memorial Fund, a 120-year-old operating foundation that improves population health and health equity by connecting leaders with evidence and sound experience. Before joining the Fund, he served the State of Rhode Island as the country's first health insurance commissioner, an appointment he held between 2005 and 2013. Under Koller's leadership, the Rhode Island Office of the Health Insurance Commissioner was nationally recognized for its rate review process and its efforts to use insurance regulation to promote payment reform, primary care revitalization, and delivery system transformation. Koller has a bachelor's degree *summa cum laude* from Dartmouth College and master's degrees in social ethics and public/private management from Yale University and is a member of the National Academy of Medicine. Koller is a professor of the practice in the department of health services, policy and practice in the School of Public Health at Brown University.

Sanne Magnan, MD, PhD | Sanne Magnan is the co-chair of the Health Care Expenditure Collaborative associated with the Roundtable on Population Health Improvement of the National Academies of Sciences, Engineering and Medicine. She was previously co-chair of the Roundtable (2015-2020). Magnan is former president and CEO of the Institute for Clinical Systems Improvement (2006-2007; 2011-2016). In 2007, she was appointed commissioner of the Minnesota Department of Health (2007-2010) and had significant responsibility for implementation of Minnesota's 2008 health reform legislation, including the Statewide Health Improvement Program, standardized quality reporting, development of provider peer grouping, certification process for health care homes, and baskets of care.

John Poelman, MPH | John Poelman is the director of Innovation at the One Utah Health Collaborative. In this role, John oversees the Collaborative's statewide efforts to identify, promote, and scale health innovations that lower healthcare costs and improve outcomes. Prior to joining the Collaborative, Poelman was a managing principal at Leavitt Partners where he helped clients understand and transition to alternative payment and care delivery models. In this role he also served as the executive director of the Accountable Care Learning Collaborative with a mission to accelerate the accountable care movement. Previously, Poelman served as a health policy analyst and special assistant to the Value-Driven Health Care Initiative at the U.S. Department of Health and Human Services. Poelman earned his bachelor's degree from the University of Utah and a master's degree in public health with an emphasis in health policy from George Washington University.

Gloria Sachdev, PharmD | Gloria Sachdev is the secretary of Health and Family Services of the State of Indiana. Prior Sachdev served as president, CEO, and board chair of the Employers' Forum of Indiana. Sachdev has also served as adjunct associate professor at Purdue College of Pharmacy and as a member of the Board of Governors for the National Alliance of Healthcare Purchasers Coalition and as board vice chair for Hoosiers for Affordable Healthcare. Sachdev received her bachelor's degree and Doctor of Pharmacy degree from the University of Oklahoma and completed a primary residency at the U.S. Department of Veterans Affairs in Madison, Wisconsin.
