CONTINGENCY PLAN DECONFLICTION TOOL

This template is a planning tool that enables users to input any airport contingency plan (Plan A) and then assess plan commonalities, conflicts and identify resource needs and improvements against any other internal or external plan used by the airport (Plans B,C, etc.).

It is designed to answer the question "Are all the contingency functions that are important to the airport present in our plans?" through a disciplined way to discern the functional commonality among plans. The tool addresses common resources shared by plans and helps identify what other resources might airports need. It also helps users document elements essential for plan integration.

When deciding whether to integrate the various contingency plans at the airport, it will be helpful to determine what the plans have in common, if they conflict, or if additional resources may be needed to improve overall efficiency. This tool assists with this analysis and identification process.

Instructions:

- 1. Determine the airport plan to assess, inserting the plan name in the Plan A cell.
- 2. Then list the other plan(s) (Plans B, C, D...) that you want to compare to Plan A.
- 3. Next, identify what resources and procedures the plans have in common.
- 4. Identify possible conflicts to consider between/among the plans, using the functional considerations listed on the following page.
- 5. Finally, identify possible resources or gaps needed to address overall improvement, and use this as your guide to de-conflicting your plans, cross-referencing them, and addressing resource implications.
